The respectifully request your office to compel SISD officials to follow the doctors orders not to seat my children directly under the light or im close proximity to sources of radiation, on the ground that following the doctors orders is necessary to prevent that my children's Electrohypensensitivity becomes as in my case, life threatening or worse; and on the ground that SISD officials have refused to follow the doctors orders in netaliation for denouncing their flaud on the Courts to conceal the harm being caused on children by the microwave radiation at school, and to conceal that the switch from wired to wireless Internet in schools was not to improve education, but for private enrichment as explained herein.

I am suffering of a painful, debilitating and Differ-threatening Electrophypersensitivity EHS. Exposure to the same radiation reaching my children at school causes me among other things, symptoms of heart attack and of stroke; swellling of vital organs and of face, head and eyes, and breathing, speech, hearing, concentration and memory problems. For the most part, I have been home bound for more than 5 years. I cannot stay inside my home, but a few minutes at a time, and I stay on a metal room placed in the middle of the lot. I have been violently ild several times. I am im pain all the time. I use oxigen during crisis. Everyday is a different niightmare. My EHS has been recognized as a medical condition and as a disability by federal and State agencies and by Counts. EHS is caused and aggravated by the same radiation reaching children at school, and proves conclusively that the microwave radiation at school is causing children harm so severe as to deflect the purpose of education. See Grievance to the State Bar against SISD counsel, Ivan F. Penez, attached.

My children are also suffering of EHS and their condition is being aggravated by unecessary exposures to radiation and by lack of expert medical evaluations for theatment of the pain and sickness that my children feel when exposed to wineless radiation. See Request to follow the doctors directions to SISD Superintendent, Dr. Robert O'Connor which includes as Exhibits the doctors letters, and details the aggravation of my childrens EHS. The Request to Dr. O'Connor includes medical documentation of my life—threatening EHS, and pictures of face and eye swelling, and showing how the swelling inside the skull is pushing one of my eyes out of its socket. Attached.

An expent in radiation exposures at schools, Dr. Samuel Milham, testified in federal Count that my children inherited my EHS, that the swelling, black spots and bloody lines on my childrens eyes were caused by exposure to the radiation at school, and that my children needed to be transferred to another school to prevent further aggravation of thier EHS. I respectfully request SISD to follow the doctors' directions to seat my children not directly under the light or in close proximity to sources of radiation. My Declaration details why it is imperative to follow the doctors' directions to prevent that my childrens Electrohypersensitivity, EHS becomes as in my case life-threatening or worse, attached. Attached are letters of my childrens doctor, and medical documentation detailing how my Electrohypersensitivity is life-threatening.

As detailed on my Declaration, it is more urgent that my child Karana I. avoids unecessary exposure to radiation as much as possible. To that effect, I am requesting that Karana be transferred to Harry Shimotsu Elementary, or that SISD provides Karana instruction at home.

Keep has attended John H. Shary Elementary since pre-k, and this school year Keep is to attend the same school for her fifth grade. DECLARATION SYMPTOMS OF MY CHILDRENS ELECTROHYPERSENSITIVITY

I am above the age of 18-years of age; I have personal knowledge of the facts contained herein; and I am competent to make this Declaration.

Page 101 of the book A Wellness Guide for the Digital Age by Kerry Crofton PhD, (2014) states in part:" "Section I - Symptoms: Please check those that may affect you when you are exposed to wired, and/or wireless devices."

Of the 29 symptoms listed by Dr. Crofton, my child K. I. checked out: Abdominal pain; aggressive moods; anxiety or depressive disorders; dry or painful eyes; erratic blood pressure; excessive sweating at night; fatigue; headaches; heart palpitations/irregular heart beat; inability to focus; irritability; light-headedness/dizziness; memory loss; nausea; nightmares; pain/disconfort in the heart area; pain in the head, neck, or shoulders, back; ringing of the ears; sensitive to noise and/or light; sleep problems; skin rashes/bumps/dryness; tingling and/or numbness in the head, hands and/or feet; and vision problems. On page 101 of Dr. Croftons book, K. Wrote: "Done by K. 22 March 2015" K. has told me that some of these effects happen after exposure.

Karaka cried in pain almost every day during the time she was placed in a classroom in close proximity to sources of radiation, including a Wi-Fi transmitter and a Wi-Fi power booster. At one time, Karaka could not move some fingers and developed a tumor in one foot, and received speech therapy.

According to Keep, on March 31, 2015, she explained to a police officer that she went to the hospital with stomach and chest pain after her mother placed a Wi-Fi inside the house; that when by mistake she used a wireless lap top, she became sick with headaches, fever and dizziness, and missed two days of school; that she had pain on the legs, and on the head and dizziness when she had been watching the TV with Wi-Fi; that her friends who have been using wireless have been sick; that the child next-door is on medicine for life after using an X-BOX; and that the TV Wi-Fi measured the full range of the meter. The full range of the Acoustimeter AM-10 is 100,000 uW/m2 of microwave radiation. Request to City of Mission Police Dept. to amend police report No. 2015-00009069.

At several times, I have observed that after K spends time around people using wireless devices, her eyes become more bloody, and at times the white of the eye becomes grey. Lately, she has been complaining more often of chest and stomach pain, of breathing problems, of pain on the legs, on the head, and of dizziness, of vision and perception problems, of a painful bubble on one ear, and of feeling something stuck on her throat. On August 4, 2015, K told me that while on a room, she started having breathing problems, and then found that there were five people in the house with cell phones.

On March 31, 2015, my child last B. checked out on page 101 of Dr. Crofton's book, aggressive moods; headaches; inability to focus; irritability; light-headedness; pain in the head; and then wrote next to the box on sleep problems: "I am told that I twitch at night but I don't feel it." On the same page, I wrote: "Done by I was 3/31/15" Afterwards, realizing that very often he feels very tired, I checked the box on fatigue:

Some of the studies prescribed for I by my child's pediatrician include a thyrod study and a grow factor for his abnormal weight loss. I has vision problems, and was monitored at a cancer clinic for his abnormal white blood cells.

On June 30, 2015, my child K. V. checked out the same symptoms that K. checked out on page 101 of Dr. Croftons book except: Dry or painful eyes; excessive sweating at night; ringing of the ears; sleep problems; skin rashes/bumps/dryness; tingling and/or numbness in the head, hands and/or feet; and vision problems. On the same page, my child wrote: "X K. Mendoza June 30th 2015"

Keeps has adviced my other two children not to use wireless devices, because of the pain that she feels when using those devices.

Ke has told me that for no reason, twice she tried to commit suicide by cutting her wrists.

In the past, K was examined for speech, sleeping, and heart problems. Last year, K told me that she was examined again for heart problems, and for painful breathing problems at the pediatrict lung center. At one time, K was hospitalized for stomach pain.

On or about July 11, 2015, at around 11:30 pm K told me that she knew that her cell was causing her harm, and that she felt that she did not want to be here anymore.

On July 13, 2015, K mother told my sister, while I was present that K tried to commit suicide on July 12, by taking pain killers.

More than 400 pages of my children's medical records document more than 60 visits of each of my three children with the same symptoms of my Electrohypersensitivity, EHS.

On a letter dated August 24, 2009, my childrens pediatrician, Dr. Ivelisse Santiago-Barouhas wrote underneat my childrens names: "Please provide an area for students to sit on chairs/desks that are not located directly under the light." Attached

On a letter dated August 23, 2010, Dr. Bantiago-Barouhas wrote below my childrens names: "Please provide an area for students to sit on chairs/ desks that are not located directly under the light or in close Proximity to sources of radiation." Attached

On April 13, 2011, an expert in radiation exposures at school, Dr. Samuel Milham, testified in federal Court that my children inherited my EHS, that the swelling, black spots and bloody lines on my childrens eyes were caused by the radiation at school, and that my children needed to be transferred to another school to prevent further aggravation of their health condition.

My three children exhibit swelling, black spots, and bloody lines on their eyes, and at times, they moan or scream in their sleep. Keep has told me that she walks on her sleep.

With exception of aggressive moods, anxiety, or depressive disorders, the symptoms of my children's EHS include the symptoms of my lifethreatening Electrohypersensitivity, and include swelling of heart and of other vital organs, symptoms of heart attack and stroke, painful breathing problems, and swelling, black spots, and bloody lines on my eyes, head and facial swelling and constant pain. With exception of some walks around the neighborhood during the year 2011, and of occasional walks to next-door neighbords, I have been home bound since March 30, 2011.

My EHS has been recognized by the Social Security, by the Texas Dept. of Aging and Disability Services, by some Courts and by other government Under penalty of perjury, entities.







I respectfully submit this Grievance against counsel for the Sharyland Ind. School District. Ivan F. Perez, on the ground that evidence on the record has proven beyond reasonable doubt the collusion of Mr. Perez with SISD officials, with the former Texas Attorney General, and now governor of Texas. Greg Abbott, with members of the judiciary, and with others, in falsification of government records, in perjury and fraud on the Courts, and in disability discrimination and retaliation against my children and against myself to conceal the aggravation of my childrens Electrohypersensitivity by the radiation exposures at school, to conceal that the same radiation reaching children at school has caused harm to teachers, to fire fighters, to police officers and to other adults; to conceal that the radiation exposures at school are increasing by 500% the childrens risk of cancer, and increasing by 450% the risk of dying to children suffering of life-threatening illnesses; to conceal that the microwave radiation at school is causing children Electrohypersensitivities, and brain, eye, blood and DNA damage and other severe physical harm that defeats the purpose of education; to conceal that the radiation exposures at school are responsible for the poor academic performance, for the increasing number of children suffering of learning and of behavioral impairments, for the thousands of visits to the schools nurse, for the thousands of student and teacher absences for health reasons, for the increasing number of children collapsing in class and committing suicide, and for the increasing number of children suffering of life-threatening and of terminal illnesses; to conceal that the switch from wired to wireless Internet in schools was not to improve education, but for private enrichment; to conceal that the lowering of academic requirements and the manipulation of grades is to conceal the harm being caused on our childrens

The Complaint of Judicial Misconduct against former 92nd District Court Judge, and now Hidalgo County Criminal District Attorney, Ricardo P.
Rodriguez Jr.; the Complaint of Judicial Misconduct against former 92nd District Court Judge, Jaime E. Tijemina; the Grievance against Assistant Texas Attorney General, Norma Ortiz; the Grievance against attorney Abel Hinojosa, and this Grievance cite to specific, concrete, and undisputed evidence on the federal and State records proving as a matter of law, the collusion of Greg Abbott with SISD officials, with members of the judiciary, and with others in falsification of government records, in fabrication of evidence, in perjury and fraud on the Courts, and in disability discrimination and retaliation against my children and against myself to conceal that the radiation exposures at school are causing harm that defeats the purpose of education. On or about August 18, 2015, I submitted by mail to Mr. Perez a Request to SISD Superintendent, Dr. Robert O'Connor to follow the doctors' directions not to seat my children directly under the light or in close proximity to sources of radiation. Mr. Perez secretary, Mellissa Escobedo acknowledged receipt of my Request. At several times, Mr. Perez has not allowed me to contact directly SISD officials and my childrens teachers and principals. I requested Ms. Escobedo to ask Mr. Perez iff I was allowed to contact directly SISD officials and my childrens principals. and teachers. Mr. Perez did not respond to my messages, or to my requests.

The Request to Superintendent O'Connor to follow the doctors directions details some of the aggravation of my childrens EHS, and notes that Mr. Perez has a conflict of interest to advice on the matter, since conclusive evidence on the record has proven his participation with some SISD officials and with others in falsification of government records, penjury, disability discrimination, finaud on the Courts and om retaliation to conceal the aggravation of my childrens HS, to deny my requests to follow the doctors directions and to transfer my children to another school, or to provide education instruction at home; to prevent that I withdraw my children from school; and to prevent further evaluations and treatment for the harm caused on my children by radiation. The Request to Superindendent O'Connor cities to a Griminal Complaint submitted to federal and State authorites detailing the collusion of SISD officials with the then Texas Attorney General, and now governor of Texas, Greg Abbott, with members of the judiciany, and with others in fraud on the Courts to conceal the harm being caused on chilnen by the radiation at school, and to conceal that the switch from wired to wireless Internet im schools was not to improve education but for private enrichment. Dr. O'Connon did not answer to my requests.

My Request to follow the doctors directions submitted to Mr. Penez includes my Statement of Disability that had been submitted with my Request for Review of child support orders to the Office of the Texas Attorney General detailing my inability to comply with the orders on a Final Decree of Divorce that had been obtained by fraud on the 92nd District Court to prevent expent medical evaluations for theatment of the pain and sickness that my children feel when exposed to wireless radiation.

At several times, agents of the Bexas Attorney General, Kem Paxtom, told me that a motion was to be filled in Court to reduce the amount of child and medical support to zero or to the amount of money that I make, which in most cases, is less than \$100 per month.

Instead, on Feb., 2016, Paxtom through his Assistant Norma Ortiz, filled a law suit to enforce by incarceration the fraudulent support orders, knowing that the support orders are part of the fraud on the Courts to prevent expert medical evaluations for theatment of the pain and sickness that my children feel when exposed to wireless radiation to concell the harm being caused on other children by the radiation at school; knowing of my inability to comply with the fraudullent support orders; and knowing that because of my life-threatening Electrohypersensitivity, incarceration is for me a death sentence. In essence, this is an attempt to silence with murder the collusion of Greg Abbott with SISD officials and with others, the fraud on the Courts to conceal thet the microwave naddation at school is causing children ham so severe as to defieat the purpose of education. DECLARATION

I certify under penalty of perjury that I am competent to make this Declaration, and that the facts stated herein are within my personal knowledge, and are true and correct.

I am suffering of a painful, debilitating, and life-threatening Electrohypersensitivity, EHS. Exposure to the radiation emitted by power lines, electric motors and transformers, fluorescent lights, wideo display screens, cell phones, wireless computers, Wi-Fi, radar, and by other sources of radiation cause me among other things, severe pain, and swelling of vital organs; of head, and of face and eyes; and breathing, speech, and concentration problems. The delayed effects of exposure to radiation have been catastrophic. With exception of some walks around the neighborhood during the year 2011, and walks to the next-door neighbords, I have been home bound since March 30, 2011. During the year 2012, I lost the ability to useeelectronic equpment to draft documents. I cannot stay inside my home but for a fiew minutes at a time. To ameliorate some of the symptoms of EHS I stay in a metal room placed in the middle of the lot, and I use shielding of the thoracic box most of the time, and at times, shielding of head at night. I use oxigen on crisis. have been violently ill several times. I am in pain all the time. Everyday is a different nightmare. My EHS has been recognized as a medical physical health condition and as a disability by federal and State agencies and by Courts. EHS is caused and aggravated by exposure to the same radiation reaching children at school. EHS proves conclusively that the microwave radiation inside schools is causing children harm that defeats the purpose of education. My children are also suffering of EHS, and their health condition is aggravating by unecessary exposures to radiation, and by lack of expert medical treatement of their EHS. (1)

(To try a radiation suit, on July 7, 2016, I walked about one and a half blocks away from my home)

In retaliation for denouncing their attempts to conceal the harm being caused on children by the radiation at school, officials of the Sharyland Ind. School District refused to follow the doctors orders to seat my children not in close proximity to sources of radiation, and refused to transfer my children to another school, and I filed Pro-se a federal law suit to compel SISD officials to follow the doctors orders, and to transfer my children to another school; and to compel SISD officials not to seat children on radiation hot spots, and to notify parents with sick children of the radiation power levels reaching children at school; to disable the Wi-Fi system at my childrens elementary school; to make a risk study of the different types of radiation reaching children at school; and to produce the real unaltered students grades, and the complete number of students and teachers reporting sickness. (2)

In response to the law suit, Mr. Perez and other SISD officials attempted to persuade my then wife to impeach in Court my mental stability, and taking advantage of her violence against my children, persuaded her to testify falsely in federal Court that my children are healthy children, and to file for divorce to deprive me of my parental rights to prevent expert evaluations for treatment of the pain and sickness that my children feel when exposed to wireless radiation. On a hearing before U.S.

Magistrate Judge, Peter Ormsby, Mr. Perez did not deny their attempts to persuade my then wife to impeach my mental stability to conceal the harm being caused on children by the radiation at school. During that hearing, Mr. Perez allowed my then wife to testify falsely that my children are healthy children, and allowed the now former principal of my children's elementary school, Pamela Montalvo, to testify that I did not submit a request to follow the doctor directions for that school year. (3)

In another hearing before Judge Ormsby, Dr. Samuel Milham, a worldclass expert in radiation exposures in schools testified that my children inherited my Electrohypersensitivity; that the swelling, black spots and bloody lines on my children's eyes were caused by the radiation at school; and that my children needed to be transferred to another school to prevent further aggravation of their health condition. (4)

In retaliation for denouncing their falsification of records, and perjury before the Court to conceal the harm being caused on children by the radiation at school, Mr. Perez and SISD officials refused to follow the doctors directions and to transfer my children to another school, and seated my children closer to sources of radiation aggravating the health condition of my then 6-year old child. During that time, my daughter complained of feeling pain while at school while hitting her head herself saying that she could not think, and that she wanted to call me so I could pick-her up from school. On a hearing before Judge Ormsby, Mr. Perez admitted his collusion with SISD officials in falsification of government records and in the retaliation against my children and against myself to prevent a dangerous precedent for the wireless Dobby. (6)

Mn. Perez has denied more than 100 requests to follow the doctors orders, and to transfer my children to another school, in retaliation for denouncing his collusion with my ex-wifes divorce attorney, Abell Hinojosa, with the then 92nd District Court Judge, and now Hidalgo County Criminal District Attorney, Ricardo P. Rodriguez Jn., and with others in penjury and fraud on the Courts to prevent expert medical evaluations for treatment of the pain and sickness that my children feel when exposed to wireless radiation to conceal the harm being caused on children by the radiation at school. Specific, concrete, and undisputable evidence on the federal record has proven beyond reasonable doubt the irrational cruelty towards children and towards the disabled of Mr. Perez and SISD officials, of Greg Abbott, of U.S. Chief District Judge, Ricardo H. Hinojosa; of U.S. Magistrate Judge, Peter E. Ormsby; of U.S. District Judge, Randy Crane; of former 92nd District Court Judge, and now Hidalgo County Criminal District Attorney, Ricardo P. Rodriguez Jr; of former 92nd District Court Judge, Jaime E. Tijerina; and of Mr. Abel Hinojosa. The same evidence has proven beyond reasonable doubt their collusion in fellonious conduct to conceal the harm being caused on children by the radiation at school. (10)

See Court Order granting my motion to appear by phone as accommodation to my EHS, Docket 13, Exh. 8; Docket 91, Apps 3-043, 3-044, Id.

See letters from my childrens pediatrician requesting that my children not be seated directly under the light or in close proximity to sources of radiation, Docket 13, Exh. 5; Docket 97, Exhs. 8.63, 8.66, A-1388, A1938, Id.

Ormsby, that my children inherited my EHS; that the swelling, black spots and bloody lines on my childrens eyes were caused by the radiation at school, and that my children needed to be transferred to another school to prevent further aggravation of their EHS. Docket 57, pgs 8, 56; Docket 81, Section 3-1, Id.

The undisputed scientific evidence on the federal and State record proving that the same radiation reaching children at school has caused harm to teachers, to fire flighters, to police officers and to other adults; and proving that these radiation exposures are causing children EHS, and brain, eye, blood, and DNA damage and other harm that defeats the purpose of education is detailed on Docket 57; Docket 81, Sections 4,5,6,7,; Docket 97, Exhibits 1.1 to 1.15; 4.25 to 4.37; 6.4 to 6.29; 8.0 to 8.94; Exh. 9; Exh. 10; Docket 91, Apps 4-017 to 4-090, Sharyland ISD et al, Id, and on the Motion for Protective Orders filled on the 92nd District Court of Hidalgo County, Texas on Feb. 13, 2012, Case No. F-1591-11-A.

Docket 101 cites to undisputed evidence on the federal record proving SISD officials falsification of government records, and more than 7 acts of perjury to the federal Court to conceal their disability discrimination and retaliation against my children and against myself after I denounced their attempts to conceal the harm being caused on children by the radiatton at school. Sharyland ISD et al, Id.

An Application for Protective Orders details the aggravation of my childrens EHS, and includes my childrens Declarations in which they they describe under penalty of perjury the symptoms of their health condition, requesting to be evaluated for treatment of the pain and sickness that they feel when exposed to wireless radiation. By mistake, Mr. Perez submitted to the Court evidence proving that Ms. Montalvoś testimony in federal Court that I did not submit a request to follow the doctorś directions for that school year was false, and then SISD officials asked the Court to withdraw that evidence. Docket 97, pg 19; Docket 101, pgs 32,33, Id.

Besides of proving Mr. Perez collusion with Ms. Montalvo to comit perjury before the federal Court, the evidence that Mr. Perez filed by mistake in federal Court corroborates his collusion with SISD officials in falsification of government records, and in disability discrimination and retaliation against my children and against myself to conceal that the radiation exposures at school are responsibel for the poor academic performance, for the thousands of visits to the school nurse, for the thousands of student and teacher absences for health reasons, and for the increasing number of children suffering of life-threatening and of terminal illnesses. Rodriguez Jr; and with others in falsification of government records, in perjury and fraud on the Courts, and on disability discrimination and retaliation against my children and against myself to prevent expert medical evaluations for treatment of the pain and sickness that my children feel when exposed to wireless radiation, and to conceal the harm being caused on children by the radiation at school.
