

RE: COMPLAINT OF CRIMES AGAINST CHILDREN.

Dear Mr. Wince,

This is a Criminal Complaint against the Texas Attorney General, Ken Paxton, and against the Governor of Texas for their participation in ongoing crimes against children.

Specific, concrete, and undisputed evidence on the record has proven as a matter of law that Mr. Paxton is attempting to enforce by incarceration support orders on a Final Decree of Divorce, knowing that the support orders were obtained by fraud on the 92nd District Court to prevent expert evaluations for treatment of the pain and sickness that my children feel when exposed to wireless radiation; knowing that because of my life-threatening Electrohypersensitivity, incarceration is for me a death sentence; and knowing that this is an attempt to silence with murder the collusion of Greg Abbott with school officials and with others in fraud on the Courts to conceal:

That the same microwave radiation reaching children at school has caused harm to teachers, to fire fighters, to police officers, and to other adults;

That the radiation at school is increasing by 500% the children's risk of cancer, and increasing by 450% the risk of dying to children suffering of life-threatening illnesses;

That the microwave radiation at school is causing children Electrohypersensitivity, and brain, eye, blood, nerve, and DNA damage and other severe physical harm that defeats the purpose of education;

That the microwave radiation at school is responsible for the poor academic performance, for the increasing number of children suffering of learning and of behavioral impairments, for the millions of visits to the school nurse, for the millions of student and teacher absences for health reasons, for the increasing number of children collapsing in class and committing suicide, and for the increasing number of children suffering of life-threatening and of terminal illnesses;

That the switch from wired to wireless Internet in schools was not to improve education, but for private enrichment;

That the lowering of academic standards and the manipulation of student grades is to conceal the harm being caused on our children's brains by the microwave radiation at school;

That taking advantage of the pervasive corruption in the State of Texas, the Obama Administration has chosen our children to start an extremely dangerous and suicidal experiment bound to cause harm even to generations to come;

And to conceal that the future of our children and of our national security are being sold to the wireless lobby as detailed on the 2nd Supplement to Criminal Complaint against Abbott and Paxton, submitted to the Special Prosecutions Division and available on the Case Law section of wirelesswatchblog.org. RE: INVITATION TO STOP THE HARM BEING CAUSED ON CHILDREN BY THE
MICROWAVE RADIATION AT SCHOOL.

This is an invitation to stop the harm being caused on our children by the microwave radiation at school.

Specific, concrete, and undisputable evidence on the federal record has proven beyond reasonable doubt how those in charge of educating and protecting our children have committed fraud on the Courts to conceal that the same microwave radiation reaching children at school is the same radiation that has caused harm to teachers to fire fighters, to police officers and to other adults; to conceal that this radiation is causing children Electrohypersensitivities, and brain, eye, blood, nerve, and DNA damage and other severe harm that defeats the purpose of education; to conceal that this radiation is responsible for the poor academic performance, for the millions of children reporting sickness in schools, for the increasing number of children collapsing in class and committing suicide, and for the increasing number of children suffering of life-threatening and of terminal illnesses; to conceal that the switch from wired to wireless Internet in schools was not to improve education, but for private enrichment; and to conceal that the future of our children and of our national security are being sold to the wireless lobby as detailed on the Criminal Complaints to federal and state authorities and available at wirelesswatchblog.org

Please share this information as much as you can with other people, with doctors, lawyers, and with congregations and organizations. Please request from school officials and from your legislators an explanation in writing to this injustice. Our children cannot defend themselves from this atrocity.

ELECTROHYPERSENSITIVITY, EHS.

I am suffering of a painful, debilitating and life-threatening Electro-hypersensitivity, EHS. Exposure to the same radiation reaching children at school, including the microwave radiation emitted by Wi-Fi transmitters, cell phones and wireless computers causes me among other things, swelling of vital organs, swelling of head, of face and of eyes, flu and allergy symptoms, rashes and loss of skin, symptoms of heart attack and of stroke, and breathing, speech, hearing, concentration and memory problems. The delayed effects have been catastrophic. I have a history of life-threatening swelling of heart. The swelling inside my skull has been so severe as to push an eye out of its socket. I cannot stay inside my home but a few minutes at a time and I stay in the back yard in a metal room. For the most part, I have been home bound for more than 5 years. To ameliorate the effects caused by radiation I use shielding of the thoracic box most of the time, and at times, shielding of the head at night. I have been violently ill several times. At times, I cannot breathe even with oxygen. I am in pain all the time. Everyday is a different nightmare. My EHS has been recognized by federal and state agencies and by Courts. To a lower degree, my children are also suffering of EHS. EHS is caused by exposure to microwave radiation and proves conclusively that the use of wireless devices in schools is causing children harm so severe as to defeat the purpose of education. Federal and state litigation has proven beyond reasonable doubt how those in charge of educating and protecting our children have committed fraud on the Courts to conceal that my children and millions of children are suffering of EHS; and to conceal that the switch from wired to wireless Internet in schools was not to improve education, but for private enrichment. Without knowing, millions of children and adults are suffering of EHS. There are refuge camps for the EHS in the U.S. EHS proves that there is a dangerous gap in medical knowledge, because most doctors know nothing about EHS and are mistreating symptoms that disappear with avoiding radiation; and because EHS can be fatal on children if mistreated with drugs.

In my family, several children were born with brain damage. The common thing in these children is that their mothers were using cell phones while pregnant. A federal judge has corroborated that cell phones emit power levels of microwave radiation exceeding the federal safety guidelines. These power levels can cause harm even to adults. The number of children with brain damage increased from 1 in 10,000 to 1 in 50, and according to experts, if we continue exposing children and pregnant women to microwave radiation, in a few years, we may have no child left without brain damage, and by the time parents become fully aware of this danger, we are bound to lose many of our children. According to experts, the power levels of microwave radiation inside schools exceeds 250,000 micro Watts per Square Meter, and only 5,000 uW/m² can cause brain damage even to adults.

Dr. George Carlo, an epidemiologist, lawyer, and chief scientist of the then largest research effort into wireless safety, in his book Cell Phones, Invisible Hazards in the Wireless Age details the research fraud between FDA officials and the then top wireless lobbyist and now head of the FCC, Thomas Wheeler to conceal that the microwave radiation of cell phones is inherently harmful to children's brains, because it penetrates the children's skulls and breaks the blood-brain barrier allowing the entry of toxics on the blood stream; and because it inflicts DNA damage, a known diagnostic marker for cancer. Dr. Carlo has denounced how the now top scientist for the wireless industry offered him research fraud to conceal the harm caused by wireless devices.

Addiction to wireless devices increases by 53% to 153% the risk of suicide. The rate of childhood cancer and suicide has dramatically increased. A children's cancer clinic in McAllen, Texas has made more than 65,000 out-patient visits, and every year receives more than 560 more children.

Brain damage on children labelled as ADHD has increased to 9%. ADHD derails nearly all aspects of the child's life even into adulthood. Accidents are the most common cause of death for these children. Attached is a list of more than 50 studies documenting the harm caused by exposure to power levels of microwave radiation below the levels reaching children at school.

No generation of children has ever faced this danger. Within the last 10 years, the power levels of microwave radiation inside schools increased more than 11 billion times. More than 15,000 scientific studies corroborate the harm caused by these radiation even to adults. It is estimated that more than 80% of the health problems now are related to exposure to radiation. This is not the first time that new technologies have caused so much harm. During the Roman Empire, it was found that lead bannells could be used to chill wine. The lead destroyed the brains of its leaders leading to the collapse of the Empire. In this case, the schools' microwave radiation is doing the same with the brains of our children and with the future of our country and of our national security.

According to scientists, the unrestricted use of wireless devices has increased the number of mental problems, of depression and suicide, of heart attacks and of strokes, and the number of cases of cancer, and predict that the harm caused by microwave radiation is bound to be worse than the harm being caused by the use of tobacco. In the U.S. more than 1,200 people die ^{every day} for causes related to use of tobacco, and these deaths are barely noticeable. The harm caused by wireless radiation is readily noticeable on the dramatic decrease in academic performance, and on the dramatic increase of children collapsing in class and committing suicide, on the dramatic increase of students and teachers reporting sickness; and on the dramatic increase of children suffering of life-threatening and of terminal illnesses. The harm caused by tobacco placed insurance companies on the border of bankruptcy. Because the harm that is expected to be caused by microwave radiation, insurance companies are not covering the harm caused by wireless devices.

Suicide is the third leading cause of death for 10-14 year olds in Texas and the second leading cause of death for those who are 15-24 years of age. According to a mental hospital, in the Rio Grande Valley there is a higher need for mental health services than ever. The McAllen school district proclaimed Sept. 10 as Suicide Awareness Day.

The bone marrow of fetuses and children absorb more than 10 times radiation than adults. Without counting children, more than 100,000 bone marrow cancers are diagnosed in the U.S. every year, and annually, more than 50,000 die from these cancers, and the number increases every year.

In the state of Texas, every year more than 30,000 babies are born prematureley or with major structural damage. This is more than the 26,000 Texans that die every year from smoking-attributed illnesses, and more than the annual deaths state wide from AIDS, heroine, cocaine, alcohol, car accidents, fire, and murder combined.

Addiction to wireless increases the risk of suicide by 53% to 153%, and it can cause the same behavioral problems caused by the use of alcohol and of other drugs.

In Sweden, one of the first countries to use wireless devices, more than 250,000 people have been diagnosed with EHS. It is estimated that just in San Francisco, more than 260,000 people may have symptoms of EHS. The World Health Organization recognized EHS after its now former President became EHS.

It is estimated that Israel has more than 800,000 people with EHS. In Haifa, one of the largest cities in Israel, the Wi-Fi has been removed from schools. The Israeli Supreme Court ordered to determine the number of school children suffering of EHS after a government official admitted publicly that EHS is caused by radiation.

Students are collapsing with cardiac arrest in Canadian schools with Wi-Fi, and teachers who complain of feeling ill in classrooms with Wi-Fi transmitters are often silenced and suffer until they are no longer able to tolerate the radiation, and go on temporary or permanent sick leave. In LA teachers with EHS were placed in classrooms without Wi-Fi.

The power company quietly removed wireless "Smart Meters" from some communities after thousands of people reacted with symptoms of EHS. These meters are known for emitting high power levels of microwave radiation. The power company has placed thousands of these meters in schools.

In Sweden, France and Germany has been prohibited or restricted the use of wireless in schools. In France is illegal to expose children under 3 years of age to wireless radiation in day care centers and in other public places.

More than 100 organizations have prohibited or restricted the use of wireless.

More than 3,000 doctors have signed a document denouncing how the wireless industry is attempting to conceal the harm caused by microwave radiation.

The American Academy of Pediatrics, representing more than 60,000 doctors has warned Congress of the harm that can be caused on children by microwave radiation.

More than 200 scientists have signed a petition to the United Nations and to the World Health Organization to warn the public of the harm that can be caused by microwave radiation on children and on pregnant women, and requesting to train doctors to recognize the symptoms of EHS.

Scientists and doctors are imploring not to expose children to microwave radiation in schools warning that this is an extremely dangerous and suicidal experiment bound to cause harm even to generations to come.

The American Academy of Environmental Medicine has trained doctors to recognize the symptoms that disappear with avoiding wireless radiation. Some of the symptoms of EHS includes:

Swelling of vital organs, and heart, breathing, speech, sleep, memory and concentration problems; symptoms of heart attack and of stroke; pain or numbness of face, head, neck, shoulders, and of hands, arms, legs and feet; Chest pain; migraines; nausea; heart rate and blood pressure problems; skin rashes and loss of skin; muscle or joint pain; face flushing; blurred vision; dry or painful eyes; nose bleeds; inability to focus; elevated sugar levels; loss of appetite; tingling, dryness, prickling and burning of skin; tooth pain; depression, anxiety, irritability, frustration, aggressiveness; ringing of the ear; digestive problems; sensitivity to noise or light; flu symptoms, and fatigue. More severe reactions include nose bleeds, panic attacks, paralysis, seizures, unconsciousness, heart attacks and strokes, and suicide tendencies.

In Michigan, Massachusetts and Main it is a crime to cause harm with radiation. In the U.S. and in Europe, law suits have been won for harm caused by radiation on people and on animals. A Texas Court prohibited long term exposure of school children to radiation.

A retired Canadian captain says that the microwave radiation used by military electronic weapons to cause harm to the enemy's vital organs, is the same microwave radiation used by the wireless devices used by children.

The Obama Administration is determined to place Wi-Fi in 99% of the schools in the country. About 30% of retirement funds shares are invested in the telecommunications industries.

In the McAllen Ind. School District, the first school district in the country in which the Obama Administration placed more than 25,000 wireless devices, parents are compelled to medicate with drugs the children that became sick with the microwave radiation. The McAllen ISD and other school districts ^{in Texas} are refusing to disclose the childrens real grades and are retaliating against those who denounce the injustice. Following the mandate of the Obama Administration, the McAllen ISD started the initiative to lower the academic requirements in the state of Texas to conceal the harm being caused on our childrens brains by the microwave radiation at school. Conclusive evidence before the Courts has proven that we are facing unprecedented corruption that has taken advantage of peoples ignorance and trust. Our children cannot defend themselves from this atrocity, and by the time people become fully aware of this corruption, for many of our children is bound to be too late.

Please share this information as much as you can with other parents, with doctors, with lawyers, and with judges, and demand from school officials and your legislators an explanation in writing to this injustice. This in turn can save childrens lives.
