My Objections submitted to Chief Judge Hinojosa point to undisputed ewidence on the record proving that to conceal the disability discrimination and retalliation against my children and against myself, the principal of my children's elementary school, Pamela Montallyo made false statements to the Court, including that I did not submit a doctor's letter for that school year. Docket 48, pgs 33,34.

See my Request flor that school year to the SISD Board of Trustees to follow the doctors orders and to transfer my children to another school including as Exhibit the doctors letter requesting to seat my children not in close proximity to sources of nadiation, Docket 32, Exhs. 6a,7a, 7b, 7c, Id.

7/2a. Without engaging the undisputed evidence proving SISD officials' falsification of government records, disability discrimination and retaliation against my children and against myself, and their perjury and firaud on the Courts to conceal the harm being caused on children by the radiation at school, on his recommendation to Chief Judge Himojosa to deny my Motions to compel SISD officials to follow the doctors' orders, Judge wrotes'

"Plaintiff must refirain from wasting the Court's time and resources and re-arguing the same matters. The undersigned will recommend that the District Court consider appropriate sanctions if Plaintiff does not cease such wasteful and burdesome litigation tactics." Pocket 75, pg 3, Note 11, Shanyland ISD et all, Id.

To prevent that I appealed the finaudullent recommendations and ru lings, Judge Ormsby wrotes

"Plaintiff should neither be provided free hearing transcripts, transcripts, nor should he be permitted to appeal without paying the filling free." Bocket 74, pg 1, Pd.

"hacking any legitimate basis, Plaintiffs attempt to pursue an interflocutory appeal is frivolous and not taken in good faith faith." Docket 74, pg 7, Id.

Despite of the endisputed ewidence on the record prowing the collusion of Judge Ormsby with SISD officials, with Judge Rodriguez and with my ex-wifes divorce attorney Abell Hinojosa imperjuny and finaudi on the Courts to conceal the disability discrimination and retaliation against my children and against myself to conceal the harm being caused on children, Chieff Judge Hinojosa dismissed my childrens claims and my claims against the SISD Board of Trustees, and denied my Motions to compel SISD officials to follow the doctors orders. Bockets 49,50,63,82,84,86,87, Id.

73. The ewidence proving the legitimacy of my EHS as a physical medical condition and as a disability remains undisputed on the federal record. See Note 11. Above.

At no time SISD officials denied their mallicious attempts during the Grievance process to discredit the legitiacy of my EHS, and did not deny their failed attempts to pensuade my then wife to impeach my mentall stability in federal Court to conceal the harm being caused on children by the radiation at school. Docket 81, pg 2. Section 11-3, Id.

My Object thions to Judge Omnsby recommendation to deny my Motions to compell SISD officials to follow the doctors orders point to Chieff Judge Hinojosa the undisputed evidence on the record proving SISD officials fails flication and attempts to fails fly government records to conceal that they are exposing children to the same radiation that causes severe physical harm even to adults. Docket 48, pgs 8-31; Docket 81, pgs 5,6, Sections 4, 5,6,7,8,9,12, Shanyland ISD et al., Id.

My fillings adopted by reflerence to my Objections submitted to Chileff Judge Linojosa (Dacket 48 pg 25) also point out to Judge Linojosa to the undisputed evidence on the record proving SISD fallsification of records and attempts to fallsify government records to conceal the harm being caused on children by the radiation at school, Docket 2,6,32, 577, pgs 10-50 and Exhibits Al, A2, A3, A4, A5, Id. See Notes above.

75. At John Shary, my childrens elementary school, out of 694 students, within 5 months 1850 children wisited the nurses office. Within 7 months, at John Shary, out of 2771 absences, 1748 children were absent from health reasons. At SISH, out of 9,473 students, within 5 months 39,392 students wisited the nurses office. During the same period, out of 38,912 absences, 21,145 students were absent for health reasons. Within 8 months at SISH, out of 9,706 employee absences, 3,245 absences were for health reasons. Petition for Recognideration of Denial of Grievance submitted to the SISH Board of Trustees and submitted to Chief Judge Tinojosa on my Objectiosm to Judge Ormsby Recommendation to dismiss my childrens claims and to dismiss my chains against the SISH Board of Trustees, Docket 32, pg 111, Docket 48, pg 25; and Docket 57, pgs 11,12,13, Id.

My objections to JudgeHinojosa point to undisputed ewidence on the record proving SISD attempts to conceal that many students at SISD are sufficiently of life-threatening and of terminal illnesses. Docket 81, Section 8-3. See Notes above.

76. My Objections to Judge Ormsby's necommendation to deny my Motions to compel SISD officials to follow the doctors orders cities to Chief Judge Himojosa to undisputed evidence on the record proving that to conceal the harm being caused on children by the radiation at school, SISD officials:

Did not allow further measurements of the radiation reaching children at school, Docket 32, pgs 7,8; Ditt. 48, pgs 311, 39; Ditt. 57 pg 40; Docket 62, pg 2; Docket 81, Section 4-7, Sharyland IS et al, Id;

Refused expert evaluations of the harm caused by the nadiation reaching children at school, Docket 32, pg 8; Docket 48, pg 44; Docket 57, pgs 6,40,51; Docket 62, pg 22; Docket 81, Sections 4-7, 4-8, Id.

Refused to disclose the location of the 50,000 - 100,000 Watts microwave transmitters operated on SISD schools, Docket 32, pg 8; Docket 48, pgs 41,46; Docket 57, pg 46; Docket 81, Section 12-6, Id.

Removed from the Grievance record ewidence proving that a Texas Court has placed a duty on school officials to measure and monitor the power levels levels of radiation reaching children at school, Docket 32, pgs 1,2; Docket 48, p 15; Docket 57, pg 24; Docket 81, Sections 8-1, 8-2, 8-3, 9-1, 9-2, Id.

And that on a hearing, without disputing the ewidence or claims proving their attempts to conceal the harm caused on children by the radiation at school, SISD officials admitted in Court that they had not measured the radiation reaching children at school because of cost, Docket 48, pg 39; Docket 57, pg 8; Docket 81, Section 8-2, Id.

My Objections submitted to Judge Hinojosa cite to undisputed ewidence on the record proving SISD officials attempts to conceal that the same microwave radiation reaching children at school has caused harm to fire-fighters and is causing children harm that defeats the purpose of education. Docket 32, pg 8; Docket 48, pgs41, 46; Docket 57, pg 46; Docket 81, Section 112-6, Id.

At no time during the federal litigation SISD officials disputed evidence or claims proving that to conceal the harm being caused on children by the radiation at school, they refused to allow further measurements of radiation on student seating areas; refused to disclose the power levels of radiation emitted by the wireless devices used inside schools; and refused to disclose the power levels of radiation reaching children at school, which were necessary to corroborate the schools dosimetry model. Docket 13, pgs 18,30,31,36,37,38; Docket 32, pg 8; Docket 57, pg 40, Id.

In Houston Lightning & Power Co. v. Klein Ind. School District, the Court placed a duty on school officials to measure the radiation reaching children at school. SISD officials removed this evidence from the record. Docket 2, pgs 6,7,; Docket 13, pgs 38,39; Docket 32, pgs 1,2; Docket 57, pg 24, Id.

A dosimetry model is vital to corroborate the harm being caused on children by the radiation at school.

"What is unique about microwave radiation is its ability to deeply penetrate into tissue and to cook or heat them up."

"The health consequences from low level exposure to microwave radiation can be catastrophic."

"What distinguishes microwave radiation is a pattern of injury that it produces, which is recognizable from the dosimetric and scientific studies."

"A dosimetry model can be an invaluable tool to help the individual see the correlation between nadiation exposure and disease."

"The value of the use of a dosimetry model is that it clearly shows what type of damage to expect."

"Any organization or company that works with radiation is required to mon monitor the level of exposure using this technique." Dr. Gerald Goldberg, Docket 13, pgs 43,44, Id. See Dr. Goldbergs letter validating the power levels of radiation found on student seating areas, Docket 91, App 3-061, Id.

Together, the San Fco. EarthLink Wi-Fi Network (2007) and Sections I of the Bioinitiative Report (2012) cite to more than 100 peer-reviewed dosimetric studies (with power levels of exposure) documenting that the power levels of microwave radiation at school are causing children EHS, and brain, eye, blood, nerve, cardiovascular and DNA damage and other sewere physical harm that defleats the purpose of education. Docket 91, Apps 4-042 to 4-064; Docket 97, Exh. 9, Sharyland ISD et al, Id.

77%. My Objections to Judge Ommsby's recommendation to deny my Motions to compellISISD officials to follow the doctors' orders submitted to Chieff Judge Himojosa cite to undisputed evidence on the record proving that im netalliation for denouncing their attempts to conceal the harm caused on children by the radiation at school, SISD officials deied more than 8 of my requests to follow the doctors' orders not to seat my children im close proximity to sources of radiation. Docket 81, pgs 3, 5, Sections 2-1, 2-2, 2-3, Sharyland ISD, Id.

Other requests to follow the doctors' orders denied by SISD officials were submitted to the Court on Docket 97, Exhs. 5.11 to 5.20, Id.

78. My Objections to Judge Ormsbys recommendation to deny my Motions to compel SISD officials to follow the doctors' orders submitted to Chief Judge Himojosa cites to undisputed ewidence on the record proving the collusion of SISD officials with Judge Rodriguez, and with my ex-wifes divorce attorney, Abel Himojosa in perjury and fraud to the 92nd District Court and to the federal Court to deprive me of my parental rights; to prevent that I transferred my children to another school; to prevent expert medical evaluations for treatment of the harm caused on my children by the radiation at school; to conceal the disability discrimination and retalliation netalliation against my children and against myself; and to conceal that the radiation exposures are causing children harm that defeats the purpose of education.

Docket 48, pgs 4,5,6,40,43,44, 52-54; sworm Application for Protective Onders and Police Report submitted to Judge Rodriguez, Docket 48, Exhs. "A" and 8, Sharyland ISD et all, Id.

My Objections point to Judge Himojosa how despite of the collusion of SISD officials to conceal my ex-wifes family violence and the aggravation of my childrens health condition, Child Protective Services and the Texas Rangers have refused to help my children, Docket 48, pgs 4,5,6, Id.

Docket 57, pgs 311,49,64,65. See proposed Temporary Orders submitted by Mr. Himojosa to Judge Rodriguez in which Mr. Himojosa attempts to deprive me of my parental nights to prevent that I transferred my children to another school and to prevent expert medical evaluations for treatment of the harm caused on my children by the radiation at school, Exhibit to Docket 57, Id.

Bocket 62, pgs 4,5,6,7,20. Exhibit "A" to Docket 62 is my ex-wifes Response to a Request flor Admissions in which she admits her violence against my children, my childrens health problems, and her perjuny to the fiederal Count to conceal the aggravation of my childrens EHS by the radiation at school, evidencing the collusion of SISD officials with Judge Rodriguez and Mr. Hinojosa in fraud on the Courts to conceal the harm being caused on children by the radiation at school. Id.

Docket 81, pgs 1b, 1c, 6,7,9. Docket 81, Sections 10-1 to 10,7; 11-2; and 12-8 cite to undisputed ewidence on the record proving SISD officials collusion with Judge Rodriguez and Mr. Hinojosa in perjuny and fraud on the Courts to conceal the harm being caused on children by the radiation at school. Id.

Undisputed ewidence on the necord proves beyond reasonable doubt that to conceal SISD officials perjuny and finaud on the Courts to conceal the ham being caused on children by the radiation at school, Judge Rodriguez:

Refused to rule on two unopposed Applications for Protective Orders detailing my ex-wifes violence against my children and detailling her attempts to conceal the aggravation of my childrens EHS by the radiation at school. Clerks Record 89-110 (Orig. Clks R. dated Jan. 27, 2015); Clerks Record 38-51 (list Supp to Clks R. dated Feb. 7, 2015), Mendoza v. Mendoza, Cause No. F-1591-11-A, 92nd District Court, Hidalgo County Texas.

Judge Rodriguez gave my ex-wife as Temponany Onders the decision on my childrens health and education, despite that my ex-wife admitted to Judge Rodriguez her violence against my children, her inability to understand EHS and her attempts to conceal my childrens EHS by the radiation exposures at school; and despite that my ex-wifes attorney, Mr. Hinojosa admitted to Judge Rodriguez the legitimacy and seriousness of my EHS. Reporters Record Voll. 3, Id.

Judge Rodriguez did not allow me to appear by phone to Count anymore as accommodation to my disability after Mr. Hinojosa did not dispute evidence proving that he removed records from my children's medical records to conceal my ex-wifie's perjury to the fiederal Court; to conceal that my ex-wifie's testimony to Judge Rodriguez that my children do not have symptoms of my EHS are fiallse; and to conceal Mr. Hinojosa's collusion with SISD officialls in perjury and fraud on the Courts to conceal the harm being caused on children by the radiation at school. Unopposed Application for Protective Orders: Clerk's Record 59-198 (2nd Supp Clk's R. dated Aprill 10, 2015), Reporter's Record Voll. 4, Id.

Undisputed ewidence on the record has proven beyond reasonable doubt that to conceal SISD officials perjury and finaud on the Counts to conceal the harm being caused on children by the radiation at school, Mr. Himojosa removed firom my childrens medical records, records documenting that two days before my ex-wife testified before Judge Rodriguez that my children do not have symptoms of my EHS, my childrens pediatrician prescribed 5 medical studies on one child fior the same symptoms of EHS and of the harm caused by radiation; records documenting 34 wishts of my child to the doctor with the same symptoms of EHS; records documenting a child's hospitalization with stomach problems, and an evaluation for heart problems; and records documenting on two children the same blood imjuriess caused by the same radiation reaching children at school. 2nd Supp Clks R. 73, 157-173, Id. See copy of some off those medical records, Docket 97, Ebshs. 3.3, 3.4, 3.5, 3.6, 3.7, Sharyland ISD et all, Id.

At no time during the flederall littigation SISD officials disputed the evidence or claims proving their collusion with Judge Rodniguez and with Mr. Hinojosa imperjury and fraud on the Counts to conceal the harm being caused on children by the radiation at school. Docket 94, pgs 52-56; Docket 97, pgs 16-18; Affidavit Paraghs 23-27, Docket 98; Docket 1101, pg 71, Sharyland ISD et al, Id.

See Mr. Hinojosas Response to a Request flor Production of documents in which he refluses to produce my childrens complete medical records and refluses to dichoe his attorney flees, Docket 97, Exhs. 4.1 to 4.9, Id.

Judge Rodriguez'sister was elected to Judge of a juvenil Court after she did not not allow me on a school meeting to explain to parents the harm being caused on children by the microwave radiation at school. See Requests to resign to Judge Rodriguez and to Judge Rodriguez-Bentancourt at winelesswatchblog.org

- After the hearings im which SISD officials did not dispute ewidence or claims of their falsification of government records and perjury to conceal their disability discrimination and netaliation against my children and against myself, I made another nequest to SISD to follow the doctors orders and not seat my children in close proximity to sources of radiation. In netaliation, SISD officials seated my children closer to sources of radiation aggravating further their health condition, and I filled a Motion for Sanctions against SISD officials. Despite of undisputed ewidence and claims proving SISD officials retaliation against my children and against myself, Chief Judge Hinojosa denied my Motion for Sanctions. Motion for Sanctions, Docket 38, pgs 5,10,11,43,44, Exhs. B,C, and D; Docket 48, pgs 3,4,34; Docket 62, pgs 2,10,11,24,25; Docket 81, pgs 3,5, Sections 2-4, 12-7, Id.
- 80. To deprive me of my right to protect my children, and despite of the ewidence on the record proving the collusion of Judge Ormsby with SISD officials, with Judge Rodriguez and with Mr. Himojosa in falsification of government necords, in disability discrimination and retalliation, and in perjury and fraud on the Courts, Chief Judge Himojosa refused to consider claims that have been proven as a matter of law by undisputed evidence on the record including my claims of wiolations of Due Process, of disability discrimination and retaliation, and of violation of parental rights. Docket 81, pgs lla, lb, lc, 2-10, Dockets 82-87, Id.

81. Docketts 47,48,49,50,51,52, Shanyland ISD et all, Id.

Undisputed ewidence on the federal record has proven beyond reasonable doubt the collusion of Chief Judge Hinojosa, Judge Ramos, Judge Ormsby, Judge Crane, Rick Penry, Greg Abbott, and the commissioner of the Social Security im falsification of government records, in fabrication of testimony and of medical evidence, and in disability discrimination, retaliation and fraud on the Courts to conceal the harm caused on my children and on myself by exposure to radiation; to deny a doctor recommended shielding room for rehabilitation of my EHS, and to deny my disability benefits; and to conceal a fraud of millions of dollars in fiederal funds. See Note 68, Above.

After I filed the law suit against SISD officialls, and to avoid confinenting the evidence proving his retaliation and fraud on his Court to conceal the harm caused on my children and on myself by radiation, Chief Judge Himojosa cancelled an Onder for a hearing to Discilose Interested Ranties.

An entry on the Courts Dockett Sheet dated 2/7/2011 states:

After SDSD officials, by mistake submitted to the Court stamped as their Exhibit a copy of my Petition to SDSD Board of Trustees, I pomited to the Court that the Petition and Exhibits corroborate my claims of SDSD officials fallsification of government records, disability discrimination and retaliation against my children and against myself, and their perjury and fraud on the Courts to conceal the harm being caused on children by the radiation at school, Pocket 94, pgs 12,13,22,31,32,34,35,40,46.48,49,50,51; Pocket 97, pgs 19,20; Docket 101, pgs 34,35,48,57,66,77, Sharylland DSD et al., Ed. Docket 1, pgs 104-113, Hinojosa et al., Ed.

Docket 101 points to the Court the fact that the same evidence that SISD officials submitted by mistake to the Court and the same evidence that they submitted to the Court in support of their Motion for Summary Judgment, proves SISD officials more than 7 acts of perjury to the Court to concell their fallsification of government records, their disability discrimination and retaliation against my children and against myself; and to concell the harm being caused on children by the radiation at school. Id.

811b Doket 11, pgs 1104-11311, Hinojosa et all Id.

82. Pages 206-216 detail the collusion of Abbott with SISD officials to conceal the legitimacy of my EHS as a physical medical condition and as a disability and to conceal the harm being caused on children by the microwave radiation at school. Bocket 1, Hinojosa et al., Id.

The irrational and criminal cruelty described herein, as in other atrocities against children, may be fitteled or exacerbated by the use of opiods. The use of psychottic drugs is all so epidemic, and in some populations, the nates are extraordinary. One im 6 American Adults Say They Have Taken Psychiatric Drugs, a Report Finds, The New York Times Dec. 113, 2016, at A22.

- 83. My hand-written, 334 pages Original Compilaint and 33 Exhibits, and the Statement of Interested Panties cite to undisputed evidence on the record prowing beyond reasonable doubt the Pefendants' irrational and criminal cruelty and retaliation against children and their collusion to conceal the crimes being committed against children. Docket 11, and Exhibits, and Pocket 4, 114, Hinojosa et all, Id.
- 84. Dockets: 5,7,111, Id.
- 85. My EHS was first diagnosed by Dr. William Rew on June 6, of 2000 at the Environmental Health Center im Dallas, Texas, and I made am Application flor rehabilitation of my EHS with the Texas Rehabilitation Commission, now the Texas Dept. of Assistive and Rehabilitative Services, DARS. On the year 2001, a TRC supervisor, Mr. Antonio Ocafa promised me before my Texas Representative Kino Flores, a shilleding room as soon as another doctor confirmed my EHS and resommended a shilleding room flor rehabilitation of my EHS. After another doctor diagnosed my EHS and recommended a shielding room flor rehabilitation of my EHS, Mr. Ocafa denied my Application for rehabilitation technology. Unopposed Motiom to Recuse Judge Crane, Docket 25, Jesus Mendoza w. Dr. David Morom et all, Case No. 7:05-cv-184 (S.D. TX, 2005).

On March of 2003, my mother sought my involuntary committment to a State hospital acting on the misbellieff that I was neglecting medical care for the swelling of my eyes and face, and acting on the misbellieff that the hospital was able to cure EHS. The same day I was taken to the emergency room wint chest pain and breathing problems. The next day, I presented to Dr. David Moron a copy of Dr. Reas diagnosis of my EHS. Dr. Moron claimed that because he never heard about EHS, then I was delusional. The next day I was subjected to another mental evaluation by a doctor familiar with EHS, Dr. Cannelius Canalampus who concluded that the only problem I had was to explain to people that electricity causes me harm. I was released immediately afterwards. ID.

After Dr. Moron reflused to include the findings of Dr. Carallampus on my medical records I filled a federal law suit to amend my medical records and to compel DARS to provide the doctor recommended shielding room for rehabilitation of my BHS. Id.

The radiation exposures inside the buildings caused me life-threatening swelling of heart as documented by the medical records of the emergency room. Docket 25, Moron et al. Id.

At no time during the fiederal litigation, the then Texas Attorney General, Greg Abbott disputed the evidence on the record proving that he, through his agents, to conceal the hamm caused by exposure to radiation and the legitimacy of EHS as a physical medical condition and as a disability, and to deny the doctor recommended shielding room, removed from my Application record among other evidence:

The Decision of the Social Security finding my electromagnetic sensitivity a sewere impairment; pictures showing swelling of face and eyes, and how the swelling inside the skull is pushing an eye out of its socket; Affidavits of persons attesting to my mental stability and to my reactivity to electricity; and an interview of the then President of the World Health Organization in which she declares her EHS. Id.

Despite that Mr. Morom did not dispute my right to amend my medical records, and to conceal Abbotts falsification of government records, disability discrimination and retalliation and to dismiss the case, Judge Crane wrote:

"Plaintiffs chains that Ms. Murray's determination that Plaintiff was elegible for rehabilitation services on his mental disability but not on his allleged electrical sensitivity wiolated his due process rights and right to be free from stigma." At no time I have claimed or testified that I have a mental disability. Unopposed Motion to Recuse Judge Crane, Docket 25, pg 9, Id.

"Plaintiff also submitted a letter from Dr. William Rea requesting a testing environment free from electromagnetic fields that could affect the outcome of Plaintiffs tests for other disorders."

Docket 118, pg 2, Moron et all, Id.

Nowhere on his letter, Dr. Rea states that I have other disorders. Dr. Rea states:

"I have evaluated this patient medical condition and it is important that the patient have a proper testing environment in order to attain maximum potential from this patient. The testing area should be devoid of any chemicals and any applicance that may emit electromagnetic filelids that could significantly affect the outcome of this patients tests." Docket 25, pg 10, 1d.

See Dr. Reas letter, Docket 116, Exhibit 111, 1d.

86. Im disclosing that her brother, Judge Crane, participated on her decisions as Trustee of the McAllen Ind. School District, Debbie Crane-Alliseda stated:

"Between Scott, Ennie, my dad (and) Randy... They would write all my speeches for me before II digo to debates (at the board meetings) she told the crowd. Then, they ditell me what I was going to say. All I had to do do at debates was remember to say, 'My name is Debbie Crane-Aliseda and this is what I believe in.' And they would make sure I knew what I believed in.'"

Four to vie to fill Scott Cranes seat, The McAllen Monitor, Reb. 15, 2015 at 1B, 3B.

Apparently, after realizing the seriousness of the incriminating statements, Mrs. Crane-Alliseda attempted to retract her statements. Id.

Administration, with MISD officials and with others to place more than 25,000 wireless devices in MISD schools; to compel parents to medicate children who became sick by exposure to the microwave radiation at school; to lower the academic standards to conceal the harm being caused on children's brains by the microwave radiation at school; and to retalliate against those who denounced the injustice is detailed on the federal law suit against Chief Judge Hinojos a and others. Docket 1, pgs 220-291,

Judge Crane has disclosed his close friendship with Chief Judge
Hinojosa. Honoring the legacy of Scott Crane, the Mcallen Monitor, July
15. 2017 at 11A, 8A.

To grant SISD officials Motion for Summary Judgment, and to conceal 88 🔐 the fraudd on the Counts to conceal the harm being caused on chilldren by the radiation at school, Judge Crane reflused to considere undisputed ewidence and cllaims proving that the ewidence SISD officials submitted to the Court by mistake, and the evidence that they submitted to the Court in support of their Motion for Summany Judgment proves SISI officialls fiallsiffication of government records and more than 7 acts of perjury to the Count to conceal their disability discrimination and retalliation against my children and against myself to conceal that the radiation at school is causing children EHS and brain, eye, blood, nerve, heart, and DNA damage and other severe physical harm that defeats the purpose of education education; to conceal that the radiation exposures at school are res nesponsible for the poor academic performance, for the thousands of neporst of student and teacher sickness, for the increasing number of children suffering of life-threatening illnesses, and for the increasing numberr of children collapsing in class and committing suicide; to conceal that the switch from wired to wireless Internet in schools was not to improve education, but for private enrichment; to conceal that the llowering of academic standards was to conceal the harm being caused om chilldrens brains by the microwave radiation at school; to conceal that taking advantage of the pervasive corruption in the State of Texas, Greg Abbott and the Obema Administration started with our chilldren an extremelly dangerous and suicidal experiment bound to cause harm even to generations to come; and to conceal that the fluture of our chilldren and of our national security are being sold to the wireless lobby. Dockets 91,92,93,94,95,96,97,98,99,100,101,105,106, 108,109, Shanylland ISD et all; Dockets 1,4,14, Hinojosa et all, Idi.

Evidence on the record proves beyond reasonable doubt the collusion of Judge Crane with Juditices of the 113th Court of Appeals in fraud on the Courts to conceal the harm being caused on children by the microwave radiation at school.

While the Travis County District Attorney and a grand jury were investigating claims that 13th Court of Appeals Chief Justice, Rogelio Valdez misappropiated court funds for personal use, an appellate Court attorney filled a law suit against Justice Valdez claiming retaliation for denouncing the thefit. The law suit was transferred to McAllen Division and assigned to Judge Crane who in turn stopped attempts by the Appellate Court attorney to compel Chief Justice Valdez to produce more evidence of the thefit of Court funds. Grand jury inquires made concerning chef Justice, the Monitor, April 9, 2015 at 6B; Valdez Keeps records requests at bay, the Monitor, April 11, 2015 118,58.

My law suit against Chief Judge Hinojosa and others cites to the evidence on the record proving Chief Justice Valldez and other Justices fraud on the 13th Court of Appeals to conceal the collusion of Judge Rodriguez, Judge Tijerina, Judge Bobby Flores, Judge Banalles, Abbott, and Mr. Hinojosa with SISD officials in disability discrimination and retaliation against my children and against myself to conceal the harm being caused on children by the microwave radiation at school. The Texas Commission of Judicial Conduct "admonished Judge Conzales for allowing an attorney to pay himself more than \$1 million from a necesivership account. State District judge sanctioned. The Monitor, Sept. 5, 2014 at 1A, 7A.

Former 113th Court of Appeals Justice, Linda Yañas sentenced a former school Board Trustee to probation for transporting 1,200 pounds of marijuana. Former trustee gets probation for transporting marijuana, the Monitor Jan.29, 2016 at 11^B.

Undisputed evidence on the record has proven beyond neasonable doubt that to conceal the collusion of SISD officials, Judge Rodriguez, Judge Banales, and Mr. Hinojosa in the fraud on the 92nd District Court to conceal the harm being caused on children by the radiation at school, and to deny my Petition for Writ of Mandamus, Justices Rose Valla, Gina Benvides, and Gregory Perkes committed fraud on the 13ht Court of Appeals. Undisputed evidence on the record has proven beyond reasonable doubt that to conceal the collusion of SISD officials with Judge Tijerina and Mr. Hinojosa in the florging of a Final Decree of Divorce to prevent expert medical evaluations for treatment of the charm caused on my children by the madiation at school, and to deny another Petition for Writ of Mandamus and to deny the appeal, Chief Justice Valldez, and Justices Garza, and Longoria committed fraud on the 13th Court of Appeals. "After nearly 15 years of serving with Chief Justice Valdez as a justice, it is with great pleasure and enthusiasm that I seek election to follow the legacy of fairness that the 13th Court of Appeals enjoys." Id.

Former 92nd District Court Judge, Jaime E Tijerina will rum for Justice on the 113th Court of Appeals. Dijerina to run for 113th Court of Appeals, the Monitor, April 25, 2017 at 3A.

" I believe in God, my country and my community here in South Texas, Tijerina said in a Monday news release." Id.

"I ficel it is now my duty to step up and flight for what is right here at home." Id.

The corruption of STSD officials continues unadressed and undeterred.

To avoid embarrassing litigation and publicity, SISD officials settled claims of retalliation against those who denounced a thefit of more than 1.6 million dollars of school funds. Sharyland ISD approves settlement for former employee, the Monitor July 9, 2015, at 11B; Sharyland district neaches agreement with administrator in grievance hearing, Jan 30, 2016, Id; Sharyland ISD moves forward with settlement, Aprill 119, 2016, Id.

In some of the attempts to avoid prison time for fellony fraud charges, Ken Paxton attempted to remove the trial Judge and defunded the State prosecutors. Attorney generalls criminal cases transferred to different county, The Monitor Junello, 2017 at 4A; Unpaid bills put trial of Texas attorney general im limbo, March 30, 2017 at &a, Id.

"It is outnageous that the prosecution should be derailed by the defendant somehow, or the defendants supporters or friends, defunding the prosecution." said Joe Turner, a veteram Austin attorney. the Monitor, March 30, 2017, at 7A, Id.

"Im 2015, Paxton accepted a \$100,000 contribution for his legal bills from the head of a company his office was investigating for Medicaid fraud despite internal agency nules that prohibit such gifts. His office at the time said Paxton was aware of the policy but that no nucles were violated." Texas attorney general donors include conservative group, the Monitor, July 6, 2017 at 34.

In a well published case of school officials retaliation, after a jury awarded the plainfitiffs millions of dollars in damages, Judge Crane dismissed the case, allowing the school Board of Trustees to settle for pennies on the dollar. The irrational and criminal cruelty described herein, as in other atrocities against children, may be flueled or exacrebated by the use of illlegal drugs. The Third Reich was flueled by hard drugs, a new book says, How Hittler's Henchmen Were Kept Hopped Up, The New York Times Dec. 110, 2016 at Cl.

Evidence on the flederal record proves that the pervasive corruption in South Texas extends to flederal agents and prosecutors.

After a jury found that FBI agents committed penjury on their attempts to frame him with heroin possession, a Mexican Mafia member filled 20 causes of action against 50 FBI agents, several unknown U.S. Customs and Border Protection agents, U.S. Marshalls agents, DPS troopers, Hidalgo County Sheriff J.E. Educado Guerra and several more fiederal government agents. Mexican Mafia member sues fieds over wrongful arrest, the Monitor, Dec. 21, 2015 at DA, 44.

"Cantus llawyer said in this instance the government acted like a a gang against his clent, arresting him and attempting to put him away for life knowing he had done nothing wrong." 44, Id.

"I believe if the governments attorney looked at the evidence more carefully, the changes should have been dropped earlier, Friedman said." Id.

The evidence presented herein demonstrates that as in other cases, federal and State law enforcement and investigative agencies, under the excuse of national security are attempting to conceal the harm being caused on children by the microwave radiation at school.

"A unit run by President Barack Obamas political staff inside the Environmental Protection Agency operates illegally as a rocal law enforcement agency that has blocked independent investigations by the EPA's inspector general for years, a top investigator says." Affiten committing firaud on the 92nd District Court to prevent expert medical evaluations of the harm caused on my children by the radiation at school, Judge Rodriguez received thousands of dollars to get elected Hidalgo County Criminal District Attorney and was hired to represent school districts. Judge resigns, announces run at DA Guerra, the Monitor, Aug. 30, 2013 at 1B, 8B; Guerra: DA's race against old ally 'will be a hurtful campaign,' the Monitor, Nov. 8, 2013 at 1B, 8B; Mission attorney to head 92nd state District Court, the Monitor, Oct. 4, 2013 at 3B; Docket 1, pgs 295, 297, 312, Docket 14, pg 31, Hinojosa et all, Id.

The former FBI Director James Commey ignored my Requests to Protect my Chilldren. wirelesswatchblog.org.

comeys FBI Public Corruption Task Force is looking the other way to school officials corruption in exchange for selling the future of our children and of our national security to the wireless vendors, while terrorising the those who denounce imjustice, and launching investigations against the lowest bidders of multi-million government proyects to allow higher bidders to take the contracts.

Impeachment and removal from office of the named federal Judges will be a strong deterrent to ongoing judicial corruption and will save the lives of millions of chilldren.

Evidence indicates that federal agents are using the pervasive public corruption for extortion, intimidation and manipulation of the State Courts to conceal the crimes being committed against children.

During the time I was in federall Court on my cliaims against some Judges for their retalliation for denouncing their fraud of millions of dollars im federall funds, a government professor at the University of Texas in Edinburg tolld me that he was also a victim of retalliatory harassment for denouncing the pervasive corruption.

During that time, the professor told me that a FBI investigation had resulted in indictment of 98 individuals which included most of the State and County Judges presiding on the Courthouse in Edinburg, and some attorneys, and public officials for bribery and other corruption.

A day after 1 attempted to make a criminal compliaint with the local FB1 offlice against the Judges that committed fraud of federal funds, 3 identified FB1 agents were caught attempting to place contraband on my car. The evidence of the failed retalliatory framing attempts was not disputed during the federal litigation. See Docket 91, Apps 3-288, 3-289, Sharyland ISD et all, Id; Docket 4, pgs 5,6, Hinojosa et all, Id.

The same day that the government professor, an attorney, and some family members were to testify before U.S. Magistrate Judge Dorina Ramos on my claims of retalliation for denouncing the fraud of millions of dollars in federal funds, Judge Ramos cancelled the hearing, impairing my abillity to reassemble witnesses. Docket 91, App 3-288, Sharyland FSD et all, Id.

During the years 2003-2004, im response to undisputed evidence on the record proving Judge Ramos' and Chilef Judge Rinojosas fabrication of testimony to conceal the retalliation for denouncing the fraud of millions of dollars in federal funds, FBI agent Rafael Unibe explained to me that the prosecution of the 98 indicated individuals was still pending, and that while under the supervission of Judge Ramos, she ordered him to comit perjury on a hearing before her Court to conceal that federal agents allowed a federal criminal to excape.

During the time I was making fillings and serving documents on the federal Court, one of my former neighbords and prosecutor, Terry Leonard and others engaged in intimidation and retalliatory harassment against myself.
