Dear Mr. Mottus:

I am the Executive Director of the National PTA. I am writing to you now concerning Wireless Education Action's request to exhibit at the 2016 Annual National PTA Convention. Please be advised that the National PTA hereby revokes Wireless Education Action as an exhibitor at the Convention. Neither the Wireless Education Action nor any of its members, representatives, and/or agents, including yourself, shall be allowed to exhibit, attend, or in any other way participate in the Convention.

As you are aware, the Screening Form for Exhibitors provides that exhibitors are subject to the National PTA's Rules and Regulations for exhibitors. Those Rules, and Regulations, provide in part, that:

#### **Restrictions in Operation of Exhibits**

National PTA reserves the right to restrict exhibitors from participation at its sole discretion. Exhibits that, because of noise, method of operation, materials, or any other reason, become objectionable may be closed. National PTA may prohibit or evict any part of or all of an exhibit that in the opinion of National PTA may detract from the general character of the exhibition as a whole. This reservation includes persons, things, conduct, printed matter or anything of a character that National PTA determines is objectionable or contrary to the exhibition. In the event of such restriction or eviction, National PTA is not liable for any refunds of rentals or other exhibit expenses.

In addition, the Screening Form requires potential exhibitors to agree that "an organization's materials must be consistent with National PTA's mission, position statements, resolutions and policies, and that any organization whose products, services or materials are not consistent with National PTA's mission, position statements, resolutions or policies will not be permitted to exhibit."

The National PTA has determined that Wireless Education Action's positions that wireless classrooms are a danger to children, that the government is covering it up, that schools are microwave radiating children without real safety standards, and

that wireless systems should be banned from schools and other locations where children are exposed to them, are not consistent with National PTA's mission, position statements, resolutions or policies.


In addition, your disruptive conduct at the American Academy of Pediatrics event, during which you sounded off a siren and used a bullhorn to disrupt the Academy's guest speaker in order to advance your agenda to garner attention against microwave transmissions, is contrary to the behavior that the National PTA requires.

Accordingly, the National PTA hereby revokes Wireless Education Action as an exhibitor. Wireless Education Action should not come to the Convention nor have any materials delivered to, or distributed at, the Convention. To the extent that you have sent any exhibit materials to the Convention facilities, please arrange for their return at your earliest convenience.
