I respectfully request help to prevent that my children's Electrohypersensitivity becomes as in my case, life-threatening or worse, and help to stop a retaliation against my children and against myself for denouncing fraud on the Courts to conceal the harm being caused on children by the radiation exposures at school.

DECLARATION

I certify under penalty of perjury that I am competent to make this Declaration, and that the facts stated in this Declaration are within my personal knowledge and are true and correct.

I am suffering of a painful, debilitating, and life-threatening Electrohypersensitivity, EHS. Exposure to the radiation emitted by power lines, electric transformers and motors, fluorescent lights, video display screens, cell phones, wireless computers, Wi-Fi, radar, and other wireless radiation, causes me among other things, severe pain, and swelling of head, face, and eyes; swelling of vital organs, and breathing, speech, and concentration problems. With the exception of some walks around the neighborhood during the year 2011, I have been home bound since March 30, 2011. During the year 2012, I lost the ability to use electronic equipment to draft documents. I cannot stay inside my home, but a few minutes at a time. To amelierate some of the symptoms of EHS, I stay in a metal room placed in the middle of the lot. I use exigen during crisis. I have been violently ill several times. I am in pain all the time. Everyday is a different nightmare.

My EHS has been recognized as a medical condition and as a disability by federal and State agencies and by Courts. EHS is caused and aggravated by exposure to the same radiation reaching children at school. EHS proves confusively that the wireless radiation inside schools is causing children harm that defeats the purpose of education. My children are also suffering of EHS, and their health condition is progressively aggravating to life-threatening by unecessary exposures to radiation, and by lack of expert medical treatment of their health condition.

In retaliation for denouncing the collusion of the former Texas Attorney General and now governor of Texas, Greg Abbott with school officials and with memebers of the judiciary in fraud on the Courts to conceal the harm being caused on children by the radiation at school, the Texas Commissioner of Family and Protective Services, Henry Hank Whitman, has refused to compel my ex-wife to follow the requests of my children to be evaluated by my doctor for treatment of the pain and sickness that they feel when exposed to wireless radiation, and to compel my ex-wife to follow the doctors directions not to expose my children unecessarily to radiation, despite that the former Commissioner, John Specia attempted to conceal my childrens EHS and my ex-wifes violence against my children; and despite that my ex-wife has admitted her violence against my children and her mental unstability, has admitted exposing intentionally my children to radiation, even when my children are asleep, and has admitted her attempts to conceal my childrens EHS. In retaliation for denouncing the malicious attempts of Greg Abbott to conceal the harm being caused on children by the schools' radiation, Assistant Texas Attorney, Norma Ortiz, filed a law suit on the 92nd District Court of Hidalgo County, Texas seeking to enforce by incarceration child and medical support orders, knowing that the support orders were obtained by fraud on the Court by the former 92nd District Court Judge, and now Hidalgo County Criminal

District Attorney, Ricardo P. Rodriguez Jr., by my ex-wifes attorney, Mr. Abel Hinojosa, and by former 92nd District Court Judge, Jaime E. Tijerina to concel my ex-wifes violence against my children; to prevent expert evaluations for treatment of the pain and sickness that my children feel when exposed to wireless radiation; to conceal my childrens EHS; and to conceal the harm being caused on children by the radiation at school. The Final Decree of Divorce submitted by Mr. Hinojosa to the 92nd District Court and signed by Judge Tijerina states falsely among other things, that I waived my right to jury trial, and that with my signature, I gave my ex-wife the exclusive decision on my childrens health and education; that I agreed to see my children only 24-hours per month; and that I agreed to pay child and medical support minimum wage. As part of the ongoing retaliation against my children and against myself, Ms. Ortiz is attempting to enforce the fraudulent orders knowing that incarceration is for me a death sentence. Without giving me the opportunity to object, Ms. Ortiz obtained a Court Order compelling my appearance to Court under penalty or arrest to a hearing on May 11, 2011, knowing that for several years I have been home bound with a life-threatening EHS that is aggravated by the radiation inside buildings. This was an attempt to silence with murder the fraud on the Courts to conceal the harm being caused on my children and on other children by the radiation at school. (4)

THE FRAUD ON THE COURTS TO CONCEAL THE HARM BEING CAUSED ON CHILDREN BY THE RADIATION AT SCHOOL.

Specific, concrete, and undisputed evidence on the federal and State records has proven as a matter of law the fact that those in charge of educating and protecting our children have committed falsification of government records, fabrication of testimony and of other evidence; perjury and fraud on the Courts, and disability discrimination and retaliation to conceal that the same radiation reaching children at school has caused harm to teachers, to fire fighters, to police officers, and to other adults; to conceal that these radiation exposures are increasing by 500% the childrens risk of cancer, and increasing by 450% the risk of dying to children suffering life-threatening illnesses, and are causing children EHS, and brain, eye, blood, and DNA damage and other severe physical harm that defeats the purpose of education; to conceal that the switch from wired to wireless Internet in schools was not to improve education, but for private enrichment; to conceal that the lowering of academic requirements was not to improve education but to conceal the harm being caused on our childrens brains by the radiation at school; to conceal that taking advantage of the pervasive corruption in this area, the Obama Administration placed more than 25,000 wireless devices into the schools of the McAllen Ind. School District to start with our children an extremely dangerous and suicidal experiment bound to cause harm to this generation and to generations to come; and to conceal that the future of our children and of our national security are being sold to the wireless lobby. The criminal attempts to conceal the harm being caused on children by the radiation at school is in violation of State and federal law including criminal attempts and conspiracies, Texas Penal Code. 15.01.02; aggravated assault. Texas Penal Code 22.02; injuries to children and to the disabled. Texas Penal Code 22.04; deadly conduct, Texas Penal Code, 22105; endangering children, Texas Penal Code 22.041; continous violence against children, Texas Penal Code 25.11; explotation of the disabled, Texas Penal Code 32.53; bribery, Texas Penal Code, 36.02; improper influence; Texas Penal Code 36.04; tampering with witnesses, Texas Penal Code 36.05; obstruction and retaliation, Texas Penal Code, 36.06; aggravated perjury. Texas Penal Code 37.03; tampering and fabricating evidence, Texas Penal Code 37.09; tampering with government records, Texas Penal Code 37.10; interference with public duties, Texas Penal Code 38.15; failure to report felonies, Texas Penal Code 38.171; abuse of official capacity. Texas Penal Code 39.02; official oppression, Texas Penal Code 39.03; misuse of official information, Texas Penal Code 39.06; and organized criminal activity, Texas Penal Code 71.02; and violations of the Matthew-Sheppards Act; of 18 USC 201, bribery of public officials; of 18 USC 241, 242, conspiracies to violate and violations of the childrens right to bodily integrity, of parental rights, of the right to access and petition the Courts, of the right to impartial triers of fact, and violations of the right to speech and to be free from retaliation for excercizing protected rights; perjury, 18 USC 1621; and violations of 18 USC 1961-1968, Racketeer Influenced and Corrupt Organizations.

For all these reasons, I am requesting help or referral to help to prevent that my children's EHS becomes as in my case, life-threatening or worse; I am requesting help or referral to help to stop the retaliation against my children and against myself for denouncing the fraud on the Courts to conceal the harm being caused on children by the radiation at school; and I am requesting investigation and prosecution of the criminal conduct described herein.

In support of my motion to compel SISD officials to follow the doctors'directions to not seat my children in close proximity to sources of radiation, and to transfer my children to another school, a world-class expert in radiation exposures in schools, Dr. Samuel Milham, testified in federal Court that the swelling, black spots, and bloody lines on my children's eyes were caused by the radiation at school and that my children needed to be transferred to another school to prevent further aggravation of their EHS. I was allowed to appear by phone to the hearing. However, the radiation emitted by the speaker of the hand set of the land-line phone caused me severe swelling of face aggravating my health condition, and I filed in Court pictures of the facial swelling in support of my motion for an extension of time to file documents.
