Dear ladies and gentlemen,

I am willing to testify in Court (By phone, health permitting) how federal and State agents and prosecutors and members of the judiciary committed fraud on the Courts to conceal that government sponsored bullying is torturing and provoking children, the disabled and others to commit mass shootings and other acts of terrorism to justify under the USA Patriot Act the use of massive and harmful military grade wireless technologies and surveillance on schools and even on homes and to benefit the trillion dollar Wireless Industrial Complex as detailed herein.

For many years, the US Dept. of Homeland Security, the US Secret Service and even the FBI have been fully aware of the fact that students and school officials torture/provoke and assist in the preparation of school mass shootings to the complicity of federal and State authorities. Evidence on the record proves the collusion of federal and State agents and prosecutors and members of the Judiciary on the fraud on the Courts to conceal that the wireless/microwave radiation at school is maiming and torturing children to death and to conceal that government sponsored bullying and harmful radiation surveillance are being used to silence the disabled and to retaliate against those who denounce government corruption. The Terror Factory by Trevor Aaronson details how most acts of terrorism have been fabricated by the FBI to justify expansions of the USA Patriot Act.

Parents Alert VII details with evidence on the federal record how federal agents attempted to create a Nuclear 9-11 to justify the harmful and massive military grade radiation surveillance of schools and even of homes to benefit the Wireless Industrial Complex. Appxs. 31-33, herein.

My Criminal Complaint to the US Inspector General for the US Dept. of Justice, Michael Horowitz details how evidence on the record proves the collusion of federal and State agents and prosecutors with members of the judiciary on the fraud on the Courts to conceal that the wireless/micro-wave radiation at school is maiming and torturing children to death and to conceal that government sponsored bullying is torturing and provoking children and the disabled to commit mass shootings and other acts of terrorism. The first page of my Criminal Complaint and Horowitz response are attached herein as Appxs. 1 and 2. A copy of the Criminal Complaint was posted on Sept. 2019 on the Case Law Section of wirelesswatchblog.org

Evidence on the record documents how for many years, when I was able to drive, I was a victim of government sponsored bullying, including pervasive high-speed road harassment, flash mobs and other attempts to injure my children and myself. See Statement of Interested Parties, id.

DISCLAIMER: Nothing herein, either by implication or otherwise threatens or advocates violence. I do not believe in violence or in anything illegal as evidence by more than 20 cases and more than 20 years of litigation defending my children and myself from government sponsored bullying including Judicial bullying and corruption.

Evidence on the federal record proves that during my second year of law school I became a victim of government sponsored bullying and of a directed radiation surveillance which caused me an Electrohypersensitivity and in retaliation for denouncing how members of the Judiciary committed fraud of millions of dollars of federal funds while giving law degrees to those affiliated to government agencies. Statement of Interested Parties, id. ELECTROHYPERSENSITIVITY, EHS.

I have been homebound for more than 7 years with a life-threatening EHS, which is caused and aggravated by directed radiation surveillance and by exposure to the same wireless/microwave radiation reaching children at school. I have been violently ill several times. At times, I struggle to breathe even with oxygen. I am sleep deprived and in pain all the time. Everyday is a different torture. This is a horrible way to die. My EHS has been recognized by federal and State agencies and by Courts as a physical medical condition and as a disability. See Statement of Disability and medical, scientific and legal evidence of my EHS, Appxs 5-20, herein.

EHS is reaching pandemic proportions. Children, teachers, doctors, attorneys, scientists and even the former Director of the World Health Organization are suffering from EHS. See wearetheevidence.org

EHS proves conclusively that the ability of the human body to absorb radiation is limited; that exposure to power levels of wireless radiation commonly found on the environment are causing severe harm even to adults; and that a massive medical malpractice and a massive Medicaid and Medicare fraud are in use to conceal the harm being caused on children by the compulsory exposures to wireless/microwave radiation at school. ^{See Appx 3.} See Parents, Alert I and II citing more than 50 peer-reviewed scientific studies of the harm that can be caused by exposure to the same power levels of microwave radiation reaching children at school. Appxs. 14, 15, 16, 17a-17f. herein.

EHS also proves conclusively that the directed radiation satellite surveillance is being used to maim and torture to death innocent, defenseless and unsuspecting victims. See Statement of Interested Parties, id. See Appx 51 and Notes, Appx 52 attached herein.

On November 2016, on a Court hearing to enforce by incarceration child support orders in which I was allowed to appear by phone as accommodation to my EHS, the Texas Attorney General, Ken Paxton admitted the legitimacy of my EHS and admitted that because of my life-threatening EHS, incarceration is for me a death sentence, and then in response to a Counter law suit and by default, Paxton admitted that his attempts to enforce by incarceration fraudulent support orders were attempts to conceal with my murder the collusion of the Governor of Texas, Greg Abbott with federal and State agents and prosecutors and with more than 25 Judges to conceal that a massive medical malpractice and a massive Medicaid and Medicare fraud are in use to conceal that the compulsory exposures to wireless/microwave radiation at school are maiming and torturing children to death. Mendoza v. Paxton, Case No. F-1591-11-A, 92nd District Court, Hidalgo County State of Texas. See Petition to Impeach 3 Federal Judges, id.

As detailed herein, I can testify in Court to the collusion of Abbott and Paxton with the Texas Rangers and with federal and State agents and prosecutors and members of the Judiciary on the fraud on the Courts to conceal that government sponsored bullying is aimed to torture and provoke children, the disabled and others to commit mass shootings and other acts of terrorism to justify the massive and harmful military grade wireless radiation technologies and surveillance on schools and homes and to benefit the trillion dollar Wireless Industrial Complex. See Appxs. 21-58 herein.

Protecting the rights of accused mass shooters may prevent government sponsored bullying from provoking more tragedies and may bring the bullies their sponsors and other terrorists to justice.

The evidence attached herein is not confidential and can be shared with interested parties including US Attorney John Bash; Assistant Attorney General Eric Dreiband; El Paso FBI Special Agent in Charge Luis M. RE: REQUEST TO CEASE AND DESIST FROM COMMITTING CRIMES AGAINST CHILDREN,
AGAINST THE ELDERLY, AGAINST THE DISABLED AND AGAINST WHISTLE BLOWERS.

Dear U.S. Attorney General, I respectfully request your office to cease and desist from committing crimes against children, against the elderly, against the disabled and against whistle blowers.

After Dr. Jorge Zamora Quezada was convicted of healthcare fraud, Assistant U.S. Attorney General, Brian A. Benczkowski of the Justice Department's Criminal Division stated:

"The conduct in this case was heinous," "Dr. Zamora-Quezada falsely diagnosed vulnerable patients including the young, elderly and disabled, with life-long diseases requiring invasive treatments that those patients did not in fact need." Zamora Quezada convicted of multiple counts of healthcare fraud; wife acquitted, the McAllen Monitor Jan. 16, 2020 at 1A,7A.

However, Mr. Benczkowski omits the fact that the U.S. Attorney for the Southern District of Texas, Ryan K. Patrick recused himself from the prosecution of Dr. Zamora in response of evidence proving:

- 1). That the prosecution of Dr. Zamora was an attempt to intimidate and silence other doctors, who like Dr. Zamora, are perceived to have the expertise to diagnose the harm being caused on children by exposure to the wireless/microwave radiation at school;
- 2). Proving the collusion of Ryan Patrick's Dad, the Texas Lt. Governor, Dan Patrick and the Governor of Texas, Greg Abbott, the Texas Attorney General, Ken Paxton, U.S. District Judges, Ricardo H. RE: STATEMENT OF PHYSICAL DISABILITIES.

"Being so severely electro-hypersensitive is like being a hermit in an infernal hell." San Fco. EarthLink Wi-Fi Network (2007) pg 25.

For the most part, I have been Homebound for more than 7 years with life-threatening Electrohypersensitivity EHS, and Chemical Hypersensitivity CHS, immunological/neurological physical health conditions and disabilities. See Exhibits A,B,C,D, and E attached herein.

Exposure to the same radiation reaching children at school, including the radiation emitted by power lines, electric transformers and motors, fluorescent lights, Wi Fi transmitters, wireless computers, cell phones and cell towers and radar, causes me among other things, pain; swelling of vital organs and swelling of face, head and eyes; symptoms of Heart attack and of stroke; rashes and loss of skin; flu and allergy symptoms; joint and muscle pain; extreme weakness and fatigue; tremors and involuntary movements; internal bleeding; and stomach, sleeping, vision, hearing, memory, concentration, speech and breathing problems. Exposure to chemical odors found inside schools and in other places causes me the same health effects. The delayed effects of exposure to radiation and chemicals have been catastrophic. I have a medical history of life-threatening swelling of Heart; my rashes and loss of skin have been life-threatening; and the swelling inside my skull has been so severe as to push an eye out of its socket. See Exhibits D1 and D2, attached herein.

I cannot be inside my home, but for a few minutes at a time and I stay in a small metal room and in other places in the backyard. Even the small amounts of radiation reaching my place aggravate my health condition. To ameliorate the symptoms of my EHS and CHS, I use shielding of eyes and of the thoracic box most of the time, and at times, I use shielding of head, face and hands. I have been violently ill several times. At times, I struggle to breathe even with oxygen. I collapsed several times. I am sleep deprived and in pain all the time. This is a horrible way to die.

My EHS and CHS have been recognized by federal and State agencies and by Courts as physical medical conditions and as disabilities. Electrohyper-sensitivity EHS, proves conclusively that the wireless/microwave radiation at school is causing children harm and disabilities that defeat the purpose of education. See Exhibits A to I attached herein.

EHS is reaching epidemic proportions. Children, teachers, doctors, attorneys; a Judge, and even a former Director of the World Health Organization are suffering from EHS. See weartheevidence.org

Despite that EHS is reaching epidemic proportions, most doctors are in the dark or in denial, and continue misdiagnosing, mismeasuring and mistreating the harm being caused on children by the wireless/microwave radiation at school. EHS proves conclusively that most doctors are committing massive medical malpractice and massive Medicaid and Medicare fraud as detailed on the Complaint of Criminal Violation of Children and of the Disabled Rights submitted to the U.S. Attorney General and posted on Sept. 2019 on the Case Law Section of wirelesswatchblog.org

He asserted that he has life-threatening "Multiple Chemical Sensitivity" (MCS) and "Electrohyper-sensitivity" (CHS). 14E/1; 23E/1. He alleged that exposure to radiation emitted by power lines, electric transformers and motors, fluorescent lights, video display screens, cell phones, wireless computers, aircraft and vehicle radar, dirty electricity etc, causes various symptoms, including: swelling of vital organs, swelling of his face, head and eyes, symptoms of heart attack and of stroke, flu and allergy symptoms, inability to sleep, rashes and loss of skin, and breathing, speech, vision, memory and concentration problems. 14E/1; 2F. He asserted that exposure to chemicals and odors found inside buildings and vehicles have similar effects. 14E/1. He claimed that he has passed out from pain and the inability to breathe on several occasions. 23E/3. He asserted that he cannot drive. 14E/1. The claimant also asserted that he cannot walk farther than the next-door neighbors' house. 14E/1. He alleged that he cannot stay in his home for more than a few minutes, so he spends his days in his yard. 14E/1. He claimed that he wears protective gear on his "thoracic box" and head.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

After careful consideration of the entire record, the undersigned makes the following findings:

1. The claimant has not engaged in substantial gainful activity since October 2, 2014, the application date (20 CFR 416.971 *et seq.*).

The claimant worked after the application date but this work activity did not rise to the level of substantial gainful activity. The claimant's earnings records show \$957.00 earned in 2015. This is below substantial gainful activity levels. 21D.

2. The claimant has the following severe impairment: immunodeficiency (20 CFR 416.920(c)).

The above medically determinable impairments significantly limit the ability to perform basic work activities as required by SSR 85-28.

Appendix 1. Electromagnetic hypersensitivity (EHS): excerpts from a summary by Dr Erica Mallery-Blythe⁸⁰

EHS is characterized by an awareness of/adverse response to even extremely weak electromagnetic fields (far below current safety levels) of varying frequencies, intensities and waveforms. It has been demonstrated to be an “environmentally inducible bona-fide neurological syndrome”. It is a primary physical issue, not a psychological one. Conscious perception can vary with age, gender and physiology. Effects can occur even in those not experiencing symptoms at a cellular level, and it is possible that everybody could potentially develop EHS as every cell in our body is dependent on electrical signals.

Common symptoms: Headaches, dizziness, sleep disturbance, sensory up-regulation, dermatological issues, palpitations, visual/auditory disturbances, membrane sensitivity, muscle twitching, hyperactivity/fatigue, memory/concentration disturbance and anxiety (psychiatric symptoms such as anxiety and depression are likely to be secondary to the physiological effects rather than a primary cause).

Exposure-induced: EHS is a cumulative, exposure-triggered condition, and exposures are rising rapidly. If EHS is unmanaged and there is general deterioration, there will be reaction to an increasingly broad range of frequencies at increasingly low intensities. The number of devices triggering symptoms will increase, symptomatic distances will decrease and irreversibility will become more likely.

The number of people with EHS symptoms who have not yet linked them to exposure is likely to be far higher than the estimated 4–10% of the population reported by several countries. Given the ubiquity of exposure in all environments, it can be difficult for people to notice the association. Extrapolated figures suggest that 50% of the population may be affected by 2017. With enough exposure, it is possible that EHS could manifest in all members of the population. Many children are affected but undiagnosed. They are more likely to develop EHS since their exposure is higher and their systems are developing.

Socioeconomic impact of EHS and human rights: EHS is already affecting a very large number of people, many of whom are unable to work due to their condition, resulting in lost revenue. An extra burden is placed on healthcare agency resources due to inappropriate diagnosis and management of common symptoms. In more severe cases, individuals are forced to live in extreme isolation, poverty and poor health, with some living in cars and tents, which can also prove threatening to health and life, especially in extreme temperatures. They cannot access basic, life-sustaining public amenities, such as grocery stores and healthcare facilities, which constitutes a clear breach of their human rights.

“I have been contacted on a daily basis by individuals with EHS, medical practitioners, school and parent groups, legal representatives, the media and political bodies looking for medical advice on EHS or the health effects of EMF in general. This is an increasingly demanding task and therefore I have founded a medical doctors’ organisation entitled PHIRE (Physicians’ Health Initiative for Radiation and Environment) in order to increase the available support for those requesting it” (<http://phiremedical.org/>).



I respectfully request your recusal from the prosecution of Raul Lopez, Case Nos. CR-0083-17-B, CR-1762-18-B, on the ground that evidence on the record shows that your family and yourself, in collusion with the Governor of Texas, Greg Abbott, the Lt. Governor, Dan Patrick, the Texas Attorney General, Ken Paxton, the Texas Rangers and federal agents are attempting to conceal that bullying is provoking shooting and other tragedies; on the ground that I have children that can become innocent victims of bully provoked shootings; and on the ground that an honest and independent prosecutor is necessary to bring bullies and their sponsors to justice as explained herein.



NEW YORK — By the tens of thousands, victims of stalking lose their jobs, flee their homes and fear for their safety, according to a new federal survey providing the most comprehensive data ever on a crime affecting an estimated 3.4 million Americans a year.

About 11 percent of the victims said they had been stalked for five or more years, and one in seven said the stalking compelled them to move out of their home, according to the report by the Justice Department's Bureau of Justice Statistics. It covered a 12-month period in 2005-06.

The study was described as a groundbreaking effort to analyze the scope and varying forms of stalking, which had not been featured in previous versions of the National Crime Victimization Survey.

The number of victims was up sharply from a more limited 1995-96 study commissioned by the Justice Department that estimated 1.4 million Americans a year were targeted by stalkers. Both surveys concluded that women more than twice as likely to be victimized as men. In the span between the two surveys, e-mail and text messaging emerged as common tactics for stalkers.

"The prevalence of these electronic devices gives stalker another tool in his tool kit, makes it easier to stalk and increases victims' fear," said Cindy Dyer, director of the federal Office on Violence Against Women. "It doesn't increase the number of stalking offenders, but it sure makes their job easier."

The Bureau of Justice Statistics defined stalking as a course of conduct, directed at a specific person on at least two separate occasions, that would cause a reasonable person to feel fear. The most commonly reported types of stalking were unwanted phone calls (66 percent), unsolicited letters or e-mail (31 percent), or having rumors spread about the victim (36 percent).

More than one-third of the victims reported being followed or spied upon; some said they were tracked by electronic monitoring, listening devices or video cameras. About 21 percent said they had been attacked by their stalker — with the forms of assault ranging from a slap to rape.

Nearly 75 percent of victims knew their stalker in some capacity — most commonly a former spouse or ex-boyfriend/girlfriend, sometimes a relative or co-worker.

"The public tends to perceive of stalking as something that happens to celebrities who have a stranger follow them around," said report co-

author Karina Baun. "This study tells us that stalking is not a stranger phenomenon."

People who were divorced or separated were more vulnerable to stalking than other

marital categories, and those aged 18-24 were more likely to be stalked than older people.

Victims reported suffering a range of emotions because of the stalking. Their most common fears included not knowing what would happen next

(46 percent) and fearing the stalking would continue indefinitely (29 percent). Nine percent of the victims said their worst fear was death.
