

## PARENT'S ALERT OCTOBER 28, 2021

For more than 7 years, the Main Stream Media has ignored the fact that two federal judges admitted in writing their collusion with the Governor of Texas, Greg Abbott, with the U.S. Department of Education and with school officials, federal and state agents and prosecutors, and with more than 25 judges on the fraud on the courts to conceal:

1. That school children are being exposed to radiation that causes harm even to adults, including radiation above the federal safety limits, and to the same microwave radiation that caused harm to teachers, to firefighters, to police officers and to other adults; (1)
