

RE: REQUEST FOR ACCOMMODATIONS TO LIFE-THREATENING PHYSICAL DISABILITIES

Dear Chief Dominguez,

I respectfully request the City of Mission Police Department to place on it's database a Physical Disability Alert which can be made immediately available to dispatchers and responding police officers to my call or to my name or address indicating:

1. That I am suffering from life-threatening Electro-Hypersensitivity EHS, and Chemical Hypersensitivity CHS, and that I may not respond to police officers commands. Please see the attached Statement of Physical Disabilities, pages 1, 2, and 3, and doctor's letter Appx 1.

Exposure to the microwaves/wireless radiation emitted by the communication devices used by police officers impairs among other things my memory, speech and concentration. See doctor's letter, Appx 1, Id.

At one time I almost got shot and arrested by a police officer that came to my place. My Texas ID states that I have a speech impediment (Texas ID No. XXXXX). Please see the Statement of Physical Disabilities, Appx 45, Id.

2. Indicating that my life-threatening EHS and CHS does not permit that I be confined inside buildings or in other places where there is radiation and/or chemical odors without suffering irreversible harm and even death. Please see the Statement of Physical Disabilities, pages 1, 2, and 3, doctor's letter, appendix 1; and pictures of life-threatening swelling of vital organs and rashes and loss of skin. Appxs 2a, 2b, and 2c.

On adversarial court proceedings, the Texas Attorney General, Ken Paxton, admitted that because of my life-threatening EHS and CHS, incarceration is for me a death sentence. Please see Motion to Appear by Phone to Judicial Proceedings as accommodations to my life-threatening EHS and CHS, appxs 47-50, Id.; and Court Orders granting my Motion, appxs 51-54, Id.

Although I am a law-abiding citizen, people have been arrested by mistake or by unknowingly or unwittingly violating the law. For this reason, I respectfully request the City of Mission Police Department that if such event occurs, to place me on home arrest to prevent aggravation of my life-threatening EHS and CHS, and to allow me to object to the grounds for arrest.

3. And indicating that my life-threatening EHS and CHS do not permit that I receive emergency health care inside a hospital, in vehicle or in other places where there is radiation or chemical odors.

Because even low levels of radiation and of chemical odors aggravate my life-threatening EHS and CHS, and because of the high levels of radiation found in hospitals, in vehicles and in other

places, emergency health care has to be provided at my place. The Statement of Physical Disabilities, pages 1, 2, and 3 and appendices 1-60 detail with medical, scientific and legal evidence my life-threatening EHS and CHS.

For all these reasons, and as accommodation to my life-threatening physical disabilities, I respectfully request that the City of Mission Police Department places on it's database a Physical Disability Alert made immediately available to dispatchers and responding officers to my call, to my name or to my address.
