

PARENT'S ALERT (FEBRUARY 2023)

DECISIONS OF THE SOCIAL SECURITY FINDINGS ELECTROMAGNETIC SENSITIVITY A SEVERE IMPAIRMENT PROVE AS A MATTER OF LAW THAT EXPOSURE TO EVEN LOW LEVELS OF RADIATION CAUSES HARM TO THE IMMUNOLOGICAL/NEUROLOGICAL SYSTEMS, EVEN TO ADULTS.

This legal decision proves as a matter of law that the chronic, compulsory, and unnecessary exposures to wireless/microwaves and “safety” radiation surveillance at schools are causing millions of children harm and disabilities that defeat the purpose of education.

For decades, the FCC has claimed that there is no evidence proving that exposure to low levels of radiation cause physical harm. The federal case of Children's Health Defense v. The FCC proved that FCC claims are false. Case No. 20-10-25 (D.C. Ct. of Appeal, 2020).

For decades, Social Security Decisions on disability determinations concluded that electromagnetic sensitivity is a severe impairment. This legal decision means that based on acceptable medical evidence, the harm caused on the immunological/neurological system by exposure to even low levels of radiation significantly impairs abilities to perform basic work activities, including: walking, seeing, speaking, hearing, remembering, understanding and the use of judgment, even to adults See: 20 CFR 404.1522 (b) (1) – (6), SSR 85-28. The fact that the Social Security recognizes electromagnetic sensitivity as a disability under the Social Security Act, and the fact that electromagnetic sensitivity is recognized by federal and state agencies AND BY COURTS as a disability under the Americans With Disabilities Act and by the Rehabilitation Act also proves as a matter of law that exposure to low levels of radiation causes physical harm even to adults. This evidence, after proper research by competent legal authority, can be used to challenge as false the FCC claims; can be used to seek disabilities accommodation for our children and others and can be used to support requests to legislators to protect children and other defenseless and unsuspecting victims from the harm caused by chronic, compulsory and unnecessary exposures to wireless/microwave and other radiation.
