

PARENTS ALERT (Oct. 2023), Amended.

Without knowing it, in the U.S. more than 50% of the population (More than 150 million people) are suffering symptoms and signs of Electrohyper-sensitivity EHS, and of Chemical Hypersensitivity CHS, which are caused and aggravated by exposure to even low levels of wireless/microwave radiation and of chemicals and fumes commonly found on the environment.

I have been homebound for more than 12 years with painful, debilitating and life-threatening Electrohypersensitivity EHS, and Chemical Hypersensitivity CHS, which are caused and aggravated by exposure to even low levels of wireless/microwave radiation and of chemicals and fumes commonly found on the environment. Exposure to the radiation emitted by power lines, electric motors and transformers, cell phones and cell towers, Wi-Fi computers and transmitters, radar, etc., causes me among other things, swelling of vital organs, swelling of face, head and eyes; symptoms of heart attack and of stroke; and sleeping, vision, hearing, speech, memory, concentration and breathing problems. Exposure to chemicals and fumes causes me some of the same health effects. See Statatement of Physical Disabilities, id.

I have a medical history of life-threatening swelling of heart; my rashes and loss of skin have been life-threatening; and the swelling inside my skull has been so severe as to push an eye out of its socket. I have been violently ill several times. At times, I struggle to breathe even with oxigen. I am sleep deprived and in pain all the time. Everyday is a different torture. This is a horrible way to die. See Appxs. 1, 2A, 2B, id.

My EHS and CHS have been recognized by federal and State agencies and by Courts as physical medical conditions and as disabilities. Statement of Physical Disabilities Appxs. 5, 7, 8, 45-60, id.

It is estimated that without knowing it, millions of people, including millions of children are suffering from EHS and CHS.

Despite of the millions of unsuspecting victims suffering from EHS and CHS; and despite that the symptoms and signs of EHS and CHS mimic the symptoms and signs of most illnesses (Including catastrophic, irreversible and deadly illnesses); most doctors are in the dark or in denial and continue misdiagnosing and mistreating with radiation and with chemicals the harm caused by radiation and chemicals, including powerful and harmful drugs, highly addictive and deadly painkillers, unnecessary invasive and dangerous surgeries. and deadly Chemo and Radioactive therapies. On August 13, 2021, and in response to more than 11,000 pages of medical, scientific and legal evidence of the widespread harm caused by wireless/microwave radiation, including EHS, the U.S. Court of Appeals for the D.C. Circuit found false the FCC and FDA claims that exposure to low levels of wireless/microwave radiation is harmless and ordered the FCC to explain why they ignored this evidence of harm. Children's Health Defense v. The FCC, Case No. 20-10-25. The FCC is still in violation of this Court Order. Appxs. 13a,13b,13c, id.

History is repeating itself. Most people do not believe that their government can cause horrifying atrocities against children and other defenseless and unsuspecting victims to benefit powerful interests.

During the Stalin era in the Soviet Union, more than 7 million men, women and children were starved to death under fabricated excuses of national security to give their land away to Soviet Oligarchs. Most farmers ignored as delusional the stern warnings to escape the slaughter.

On his book Night, Elie Wiesel details how the Nazis came to his Jewish town to take men, women and children to be slaughtered, and how the town's people regarded as delusional the stern and repeated warnings to escape the slaughter. Wiesel details how even when he was watching in first row and in real time how the Nazis were throwing screaming children into fiery pits fueled by living human beings, he still resisted the idea that people could cause such atrocities on children and on other defenseless victims.

The 1994 movie, Blue Sky details how under fabricated excuses of national security, a nuclear engineer was sent to a mental hospital after he pointed out that the deadly radioactivity of the nuclear bombs that they were testing was to kill thousands of farmers in the State of Alabama. The movie details how when his wife realized the malicious scheme, she complained to authorities to no avail, and then she warned the farmers.

To her dismay, the farmers ignored the stern warnings because they did not believe that the government could do such atrocity to them.

The movie The Titanic details how the captain was shocked when he learned that most of the passengers were to die on the frigid waters. Undisputed evidence on the record of federal Courts has proven that for more than 20 years, the Social Security has admitted that my Electrohyper-sensitivity EHS, is a disability under the Americans with Disabilities Act, under the Rehabilitation Act, and under the Social Security Act.
