

PARENTS ALERT (Nov. 2023).

EHS and CHS prove conclusively as a matter of fact that the massive medical errors of doctors without expertise in Environmental Medicine are foreclosing any possibility of a cure on millions of children and of other defenseless and unsuspecting victims, and prove conclusively as a matter of fact that these massive medical errors are a National Health Emergency.

I have been homebound for more than 12 years with painful, debilitating and life-threatening Electrohypersensitivity EHS, and Chemical Hypersensitivity CHS, which are aggravated by exposure to even low levels of wireless/microwave radiation and of chemicals and fumes commonly found on the environment. My EHS and CHS have been unrecognized by federal and State agencies and by Courts as physical medical conditions and as disabilities under the Americans with Disabilities Act and the Rehabilitation Act.

Although EHS and CHS are recognized by the medical community, EHS and CHS are not taught in medical school. EHS and CHS are diagnosed and treated by doctors with expertise in Environmental Medicine. The best treatment for EHS and CHS is avoidance of all radiation and chemicals; removal of heavy metals and of other environmental toxicants from blood and tissue; and proper nutrition.

It is estimated that without knowing it, more than 150 million Americans (More than half of the US population), especially children are suffering symptoms and signs of EHS and CHS, which mimic the symptoms and signs of most illnesses, including catastrophic, irreversible and deadly illnesses and disabilities. 
