EVIDENCE ON THE RECORD HAS PROVEN THE FRAUD ON THE COURTS TO CONCEAL THAT THE MICROWAVE RADIATION REACHING MILLIONS OF OUR CHILDREN AT SCHOOL IS SIMILAR TO THE RADIATION USED TO MAIM AND TORTURE THE ENEMY TO DEATH.

On a Declaration under penalty of perjury to a federal Court, a former agent of the British Military Intelligence and expert in RADIATION WARFARE testified that for DECADES, microwave radiation similar to the Wi-Fi microwave radiation reaching children at school has been used AND IS USED:

The Supreme Court of Alaska corroborated the fact THAT EVEN SHORT DOSES OF MICROWAVE RADIATION ABOVE THE FCC SAFETY LIMITS CAUSE DISABLING BRAIN DAMAGE EVEN TO ADULTS. AT & T v. Orchid, Case No. S.12058 (2007).

In response to a FOIA request by the Environmental Health Trust, the FCC produced documents corroborating the fact that the FCC and the FDA are concealing that the cell phones used by millions of our children emit power levels of microwave radiation exceeding the FCC safety limits which cause even in short doses, severe harm even to healthy and strong adults.
