FEDERAL INVESTIGATIONS AND COURT CONTEMPT ORDERS CORROBORATE THE ATTEMPTS OF GREG ABBOTT TO CONCEAL THE HEINOUS ATROCITIES BEING COMMITTED AGAINST MILLIONS OF OUR CHILDREN.

On the year 2020, U.S. District Judge, Janis Jack found Abbott (Again) in contempt of the Court for allowing child abuse and neglect.

Judge again finds state in contempt over foster care, the McAllen Monitor, Dec. 20, 2020 at 8B. (Forcing massive psychotropic drugs on children without proper evaluations).

On the year 2022, Judge Janis asked investigators to look into claims of Abbott allowing sex trafficking of children after the Director of the Texas Rangers, Steve McArw claimed falsely to the Court that there was no evidence of these crimes even before the Texas Rangers interviewed the victims. Judge calls for federal inquiry in child sex abuse case, the Monitor, March 31, 2022 at 3A.

The same year, Abbott was found to incarcerate children in Guantanamo-like prisons. "The 5 youth prisons in Texas are functioning as mini-Guantanamos."

Behind the Gates, Texas is throwing away children in youth prisons, the Monitor Aug. 29, 2022 at 8A.

At several times, Judge Jack has found Abbott in contempt for allowing Child Protective Services and the Texas Rangers and others to engage in mass and forced medication of children and for allowing physical and sexual assaults of children.

Judge: Foster kids in peril, the Monitor, Jan. 29, 2023 at 1A, 12A.

On the year 2024, Judge Jack fined Abbott \$100,000 per day until Abbott, Child Protective Services and the Texas Rangers ceased and desisted from their criminal atrocities against our children.

As expected, corrupt Judges from the federal Court of Appeals quickly intervened to remove Judge Jack from the case because she had shown compassion for our children and to allow the massive and heinous criminal atrocities against millions of our children continue unaddressed, undeterred and with impunity.
