The death of Mr. Firstenberg "came about six months AFTER BEING STRIKEN BY A SUDDEN REMOTE ATTACK FROM AN UNKNOWN FORCE, on August 20, 2024.

"Firstenberg was born in 1950 in Brooklyn, New York, into a Jewish family, survivors of the Holocaust."

Mr. Firstenberg was the first person that I met by phone, and that like myself, was suffering from Electrohypersensitivity EHS. It was around 1998, and at that time, he had pending a case on the U.S. Supreme Court. The Cellular Phone Task Force v. The FCC.
