The same evidence has proven that these acts of domestic terrorism represent a clear, present and immediate existential threat to millions of our children, to our country and to our Constitutional Republic.

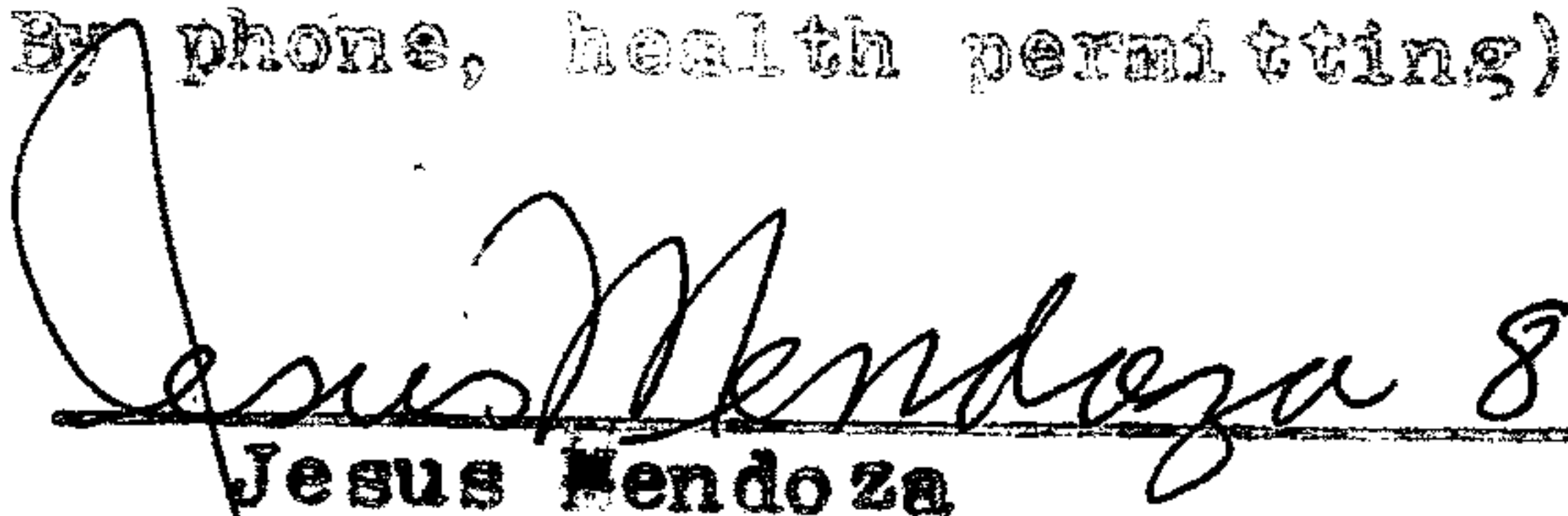
The same evidence has proven that the destruction of millions of our children and the destruction of our country and national security continue unaddressed, undeterred and with impunity.
