Dear U.S. Attorney,

This is a Complaint of Criminal Violation of Constitutional and Statutory Rights against the Governor of Texas, Greg Abbott and against named Criminal Actors, as detailed herein.

Your prompt investigation and prosecution of this Criminal Complaint of ongoing criminal activity:

- 1- Can stop and prevent immense pain and suffering;
- 2- Can save the lives of millions of our children and the lives of millions of other defenseless and unsuspecting victims;
- 3- And can restore the Judiciary, our health and medical care, and our Constitutional Republic to their original intent as detailed herein.

RE: COMPLAINT OF CRIMINAL VIOLATION OF CONSTITUTIONAL AND STATUTORY RIGHTS.

In violation of two federal Court Orders, the top federal Criminal Prosecutor in this area, U.S. Attorney Alamdar S. Hamdani refused to engage the evidence on the record detailing the collusion of the Governor of Texas, Greg Abbott, the Texas Rangers and Child Protective Services with U.S. District Chief Judge, Randall Crane, with U.S. District Judge, Ricardo H. Hinojosa and with U.S. District Court Judge, Micaela Alvarez and others on the most horrifying criminal atrocities ever committed against millions of our children, as detailed by the Petition to Impeach 3 Federal Judges (Aug. 2024) and Exhibits A, B and C submitted to Jim Jordan, Chair of the U.S. House of Representatives Judiciary Committee. +

On the year 2023, I submitted to Mr. Hamdani a Complaint of Domestic Terrorism against Abbott and against the Director of the Texas Rangers, Steve McCraw and others for their criminal attempts to conceal that FBI Terror Hate Group Bullying (Which includes school officials, teachers and students) is provoking children, the mentally disabled and others to make death threats, and to commit mass shootings and other terrorism. ++

I requested Mr. Hamdani to investigate and prosecute the bullies that are provoking death threats, mass shootings and high-speed road accidents on the ground that his intervention can stop and prevent these acts of ongoing terrorism. On a letter dated April 14, 2023, Mr. Hamdani claimed referring the Complaint to the FBI and to the Special Prosecutions Division in Austin to allow these acts of domestic terrorism against our children continue unaddressed, undeterred and with impunity as detailed herein. +++

EVIDENCE ON THE RECORD HAS PROVEN MASSIVE FRAUD ON THE COURTS AND MASSIVE  
ABROGATION OF THE LAW AND OF JUDICIAL INTEGRITY TO CONCEAL THAT MASSIVE  
MEDICAL ERRORS ARE MAIMING AND TORTURING MILLIONS OF OUR CHILDREN TO DEATH.

Specific, concrete and undisputed medical, scientific and legal evidence on the record has proven the collusion of Greg Abbott with other named criminal actors:

- 1- In tampering and falsification of government records;
- 2- In fabrication of medical evidence, and in fabrication of witness testimony and of other evidence;
- 3- And in perjury and fraud on the Courts to conceal among other criminal atrocities;
- 4- That the wireless/microwave radiation and the chemicals and fumes at school are causing millions of children Electrohypersensitivity EHS, and Chemical Hypersensitivity CHS, and BRAIN, EYE, BLOOD, NERVE, HEART AND DNA DAMAGE and other catastrophic, irreversible and deadly harm and disabilities THAT DEFEAT THE PURPOSE OF EDUCATION AND LIFE;
- 5- To conceal that the symptoms of EHS and CHS, including THE PAIN AND SWELLING OF BRAIN AND HEART AND OF OTHER VITAL ORGANS MIMIC AND ARE CONFOUNDED WITH SYMPTOMS OF MOST ILLNESSES;  
(Including symptoms of Cardiac Arrest and of Heart Attack and Stroke)
- 6- To conceal that MOST DOCTORS ARE IN THE DARK OR IN DENIAL OF ENVIRONMENTAL MEDICINE, of the pain and swelling of brain and heart and of other vital organs caused/aggravated by Environmental Toxicants;
- 7- And to conceal THAT MOST DOCTORS are misdiagnosing and mistreating THE INJURIES caused and aggravated by exposure to CHEMICALS AND RADIATION WITH CHEMICALS AND RADIATION, including:
  - i+ Powerful and harmful drugs;
  - ii- DEADLY PAINKILLERS;
  - iii- And DEADLY CHEMO AND RADIATION THERAPIES, as detailed herein. (1)<sup>+</sup>  
(THIS IS LIKE TRYING TO EXTINGUISH A FIRE WITH GASOLINE!).

EVIDENCE ON THE RECORD HAS PROVEN THE FRAUD ON THE COURTS TO CONCEAL THAT THE WIRELESS/MICROWAVE RADIATION AT SCHOOL AND MASSIVE MEDICAL ERRORS ARE MAIMING, DISABLING AND TORTURING MILLIONS OF CHILDREN TO DEATH.

On the year 2011-2012 school year, Chief Judge Crane, Greg Abbott and the U.S. Dept. of Education participated on the decision:

- 1- To make of the McAllen School District the first in the country to deploy in its schools a massive amount of powerful and harmful military grade wireless/microwave technologies;
  - 2- On the decision to conceal that the massive exposures to microwaves at school is causing millions of children Electrohypersensitivity EHS, and brain, eye, blood, nerve, heart and DNA damage and other catastrophic, irreversible and deadly harm and disabilities that defeat the purpose of education and of life;

However, the AI Radiation Surveillance used in schools is not programmed to account for BRAIN and other damage caused by FBI Terror Bullying and by exposure to the massive, and powerful military grade wireless/microwave technologies at school and which may include:

EVIDENCE ON THE RECORD HAS PROVEN THE FRAUD ON THE COURTS TO CONCEAL THAT MASSIVE OFFICIAL/JUDICIAL TERRORISM IS MAIMING AND TORTURING TO DEATH MILLIONS OF CHILDREN AND OF OTHER DEFENSELESS AND UNSUSPECTING VICTIMS.

On the year 2019, an attorney testified in the McAllen federal Court that for decades, the Judiciary in this area HAS REPLACED THE RULE OF LAW FOR THE "VALLEY LAW", meaning CASH for Court rulings, judgments, appeals, etc. Delgado gets 5 years, the Monitor Sept. 26, 2019 at 1A.

On the year 1998, a government professor shared that 98 Judges and attorneys in this area had been indicted on bribery and other felonies.

The Governor of Texas, Greg Abbott has admitted publicly that the public official corruption in the State of Texas (Without excluding himself) mimics the corruption of third-world countries.

The evidence on the record has proven that JUDICIAL TERRORISM:

- ii- To benefit Organized Crime, including the Wireless, Big Pharma and the Medical Cartels and other corrupt and treasonous forces;
- iii- And to destroy our country from inside as detailed herein.

EVIDENCE ON THE RECORD HAS PROVEN FRAUD ON THE COURTS TO CONCEAL THAT UNDER FABRICATED EXCUSES OF NATIONAL SECURITY HATE INSIDE AND OUTSIDE GOVERNMENT AGENCIES IS DESTROYING OUR COUNTRY FROM INSIDE TO BENEFIT ORGANIZED CRIME.

According to government and history experts, last century, the Texas Rangers, in collusion with hate groups maimed and tortured to death more than 5,000 Mexicans in this area to take their land away. +

EVIDENCE ON THE RECORD DETAILS THE FBI/CIA/NSA POLICE STATE FAILED ATTEMPTS TO CREATE A NUCLEAR 9-11 TO JUSTIFY UNDER THE FABRICATED EXCUSES OF NATIONAL SECURITY MASSIVE/WARRANTLESS THROUGH-WALL HARMFUL SATELLITE SURVEILLANCE.

A former president of American Airways claimed in federal Court in Brownsville, Texas that he had been framed into child pornography in retaliation for denouncing that federal agents attempted to smuggle a portable nuclear bomb that was to be detonated on an American city.

U.S. District Judge, Andrew Hanen was so alarmed that he said that he was to share the information with other Judges. However, Judge Hanen did not allow the evidence of the failed Nuclear 9-11 be placed into the record. In response to undisputed evidence on the record proving school officials retaliatory bullying for denouncing their fraud on the Courts to conceal that the radiation at school is maiming and torturing millions of children to death, U.S. District Chief Judge, Ricardo H. Hinojosa and U.S. Magistrate Judge, Peter Ormsby claimed in essence:

- 1- That school officials can maim and torture to death school children with immunity and with impunity;
- 2- That there was no conceivable relationship between school officials and the retaliatory bullying;
- 3- And that I should have been subjected to sanctions for denouncing these criminal atrocities.

In response to a federal lawsuit against them, and with their signature, both, Judge Hinojosa and Judge Ormsby admitted their criminal and irrational retaliation against children and the disabled and admitted and corroborated their criminal collusion with the named criminal actors in massive fraud on the Courts and in massive abrogation of the law and of Judicial integrity to conceal the criminal atrocities being committed against millions of our children and detailed herein. PAXTON ADMITTED IN COURT HIS ATTEMPTS TO CONCEAL WITH MY MURDER THE COLLUSION OF GREG ABBOTT AND THE JUDICIARY TO CONCEAL THAT MASSIVE MEDICAL ERRORS ARE MAIMING AND TORTURING MILLIONS OF CHILDREN TO DEATH.

On the year 2016, the Texas Attorney General, Ken Paxton attempted to enforce by incarceration child support Orders, knowing that the Orders had been obtained by fraud on his Court by then 92nd District Court Judge Jaime E. Tijerina, and knowing that because of my life-threatening Electrohypersensitivity EHS, and Chemical Hypersensitivity CHS, incarceration is for me a death sentence. Paxton <sup>n</sup>vs Medoza, Case No. F-1591-11-A. (6)

On a hearing in which I was allowed to appear by phone, my Court appointed attorney read to the Court my doctor's letter detailing how because of my life-threatening EHS and CHS, incarceration is for me a death sentence. In response, Paxton withdrew his motion to put me in jail, recognizing my EHS and CHS as physical disabilities under federal law.

However, Paxton resumed his attempts to enforce by incarceration the fraudulent support Orders, effectively placing me in death row for more than 3 years. See my Declaration under penalty of perjury, pages 76 - 79 to Exhibit A to Petition to Impeach 3 Federal Judges. (7)

On the year 2019, and by default to two counter lawsuits, Paxton admitted that he attempted to enforce by incarceration the fraudulent support Orders to conceal with my murder the criminal collusion of Greg Abbott with Judge Tijerina, Judge Rodriguez, Chief Judge Crane, Judge Hinojosa, Judge Alvarez and with the U.S. Dept. of Education and school officials on the fraud on the Courts to CONCEAL THAT MASSIVE MEDICAL ERRORS AND MASSIVE MEDICAID AND MEDICARE FRAUDS ARE MAIMING AND TORTURING TO DEATH MILLIONS OF CHILDREN AND MILLIONS OF OTHER DEFENSELESS AND UNSUSPECTING VICTIMS as detailed herein.

Greg Abbott appointed Judge Tijerina to the 93rd. District Court and to the Texas 13th. Court of Appeals. (Despite of Judge Tijerina's corruption).

On the year 2018, former Secret Service agent, Dr. Marisa Reddy Randazzo appeared before the Secretary of the U.S. Dept. of Education, Bettsie DeVos, and before the Secretary of the U.S. Dept. of Homeland Security, Kirstjen Nielsen and U.S. Attorney General, Jeff Sessions and others to detail how the SAFE SCHOOL INITIATIVE was still considered to be the landmark federal study on school shootings.

The Statement of Dr. Randazzo before the Federal Commission on School Safety is attached herein at pages 68 - 72.

The Safe School Initiative 2000, 2002, 2004, 2018 detail how in most cases, students assist, encourage and provoke children to commit mass shootings, and how school officials and teachers are complicit in these crimes by their silence and compliance with the FBI, and with local and State and federal authorities, to conceal that pervasive bullying is provoking these acts of terrorism.

Evidence on the record has proven the collusion of Judge Rodriguez with Greg Abbott, and with Chief Judge, Crane, Judge Hinojosa and Judge Alvarez with school officials and others on the fraud on the Courts to conceal among other heinous criminal atrocities against our children:

- A- That the wireless/microwave radiation and FBI Hate Group Bullying at school are maiming, disabling and torturing to death millions of children;

(Abbott appointed Judge Bentancourt to the Juvenile Court).

To conceal the collusion of Judge Bentancourt with Greg Abbott, the Texas Rangers and Child protective Services and other criminal cohorts on the fraud on the Courts to conceal that **MILLIONS OF CHILDREN'S BRAINS** and bodies have been injured and disabled by the wireless/microwaves and by FBI Terror Bullying at school, Criminal DA Palacios stated in part:

"We see kids that have mental issues. So we could catch it early,"

Despite the fact that for years, local, State and federal authorities have been briefed with the evidence proving the fraud on the Courts to conceal these massive criminal atrocities, U.S. Representative Vicente Gonzalez and Hidalgo County Judge, Richard Cortez among others are pretending ignorance. After complimenting law enforcement and school leaders: "Gonzalez said individuals behind the threats were attempting to terrorise the community. 'We will not tolerate this behavior' he wrote."

Judge Cortez stated in part: "As details of the tragedy in Uvalde emerge, we cannot help but suffer together. An attack on any child is an attack on the moral fabric of our society. EVIDENCE ON THE RECORD HAS PROVEN MASSIVE FRAUD ON THE COURTS AND MASSIVE ABROGATION OF THE LAW AND OF JUDICIAL INTEGRITY TO CONCEAL THAT FBI TERROR BULLYING IS PROVOKING CHILDREN TO COMMIT MASS SHOOTINGS AND OTHER TERRORISM.

A 15-year old child was killed by police after he brought a toy gun to school. Chaos Captured, the Monitor, Jan. 6, 2012 at 1A, 7A.

Following the same directed routine, the FBI, the Texas Rangers and local authorities rushed to the scene to conceal that FBI Terror Bullying (Which includes school officials, teachers and students) provoked the child to bring the toy gun to school.

THESE HEINOUS ATROCITIES ARE TRAUMATIZING EVEN ADULTS.

Garza, a school counselor, through her attorney, Mark Robinett "...said specifically that there were two students who he said Garza felt were suicidal because they were being bullied by a teacher."

Administration waved the claim off, Robinett said, but on Oct. 17, 2019, she saw that teacher bully one of those students again.

"And at this point, Ms. Garza just lost it, she couldn't take the fact that this was going on anymore," Robinett said."

"And it hit her hard. She was stunned by it."

"She was traumatized by it."

More allegations at Weslaco ISD grievance hearing, the Monitor, Feb. 20, 2020 at 1B, 12B.

A school teacher was bullied by students, teachers and by school officials and even by school police to the complacency of the FBI and the Texas Rangers, and of the local police. Former RGV teacher alleges beating by school police, the Monitor Aug. 8, 2019.

And these criminal atrocities are just the tip of the iceberg, as detailed herein.

Evidence on the record has proven how FBI Terror Hate Group Bullying has infiltrated school officials, teachers and students nationwide:

- 1- To provoke children, the mentally disabled and others to make death threats, and to comit mass shootings and other terrorism;

"Since the shooting, Runcie and Broward County district administrators have been accused by critics of lying about school crime rates and discipline problems in official reports. For example, Stoneman Douglas reported zero incidents of bullying among its 3,200 students between 2014 and 2017 and three incidents of vandalism." Page 2, id. (Emphasis mine)

"One of my first observations of the magnitud of corruption/malfeasance in the Valley was the field of local education. In the North and East, where I lived for many years, it was difficult to find candidates for local education board. In the Valley, however, candidates will campaign and spend thousands of dollars to be elected to boards and commissions that control education facilities and staffing. Why such an interest here?" In preparation to the catastrophic, irreversible and deadly harm and disabilities caused on millions of children's brains and bodies by the massive exposures to the radiation at school, Abbott has already in place remote telemedicine and remote psychiatric evaluations of children. +

The Uvalde massacre was blamed in part to an "unlocked door." However, Greg Abbott's massive deployment of wireless "door safety technologies" in school campuses was already in progress before the Uvalde tragedy.

"Metal detectors are being installed at two Santa Rosa school campuses to ensure the safety of students and staff, officials said." Santa Rosa ISD to install metal detectors in two campuses, the Monitor Feb. 22, 2023 at 4A.

The Governor of Texas, Greg Abbott is an individual with Presidential aspirations who despite of being disabled and on a wheel chair for most of his life, has committed fraud on the Courts to conceal that Organized Crime is maiming and torturing<sup>+</sup> to death millions of our children and millions of other defenseless and unsuspecting victims. + (And disabling)

#### CHILD ENDANGERMENT.

Placing a child in imminent danger of death, bodily injury or of physical or mental impairment. Texas Penal Code 22.041

#### INJURY TO A CHILD OR TO THE DISABLED.

Causing mental impairment or bodily injury to a child or to the disabled. Texas Penal Code 22.04

#### EXPLOITATION OF A CHILD OR OF A DISABLED.

The illegal or improper use of a child or disabled resources for personal benefit. Texas Penal Code 35.53

#### NOTE 1.

Although private schools may be held criminal liable for injuring children, and specially disabled children, they may not have the duty or may not be compelled to evaluate whether the children's learning, behavioral or aggressiveness are caused or aggravated by the massive exposures to wireless/microwave radiation at school.

This is another of Abbott's attempts to conceal the massive fraud on the Courts and the massive abrogation of the law and of Judicial integrity to conceal the criminal and heinous atrocities being committed against millions of our children and detailed herein.



#### CHILD NEGLECT.

Failing to seek, obtain, or follow through with medical care for a child, which results in a substantial risk of death, disfigurement, or bodily injury, or in an observable and material impairment to the growth, development or functioning of the child.

#### CHILD ABUSE.

Causing or permitting the child to be in a situation in which the child sustains a mental or emotional injury that results in an observable and material impairment in the child's growth, development, or psychological functioning. Texas Family Code, 261.001(1)(B);

Physical injury that results in substantial harm to the child, or the genuine threat of substantial harm from physical injury to the child. Texas Family Code, 261.001(1)(C);

Failure to make a reasonable effort to prevent an action by another person that results in physical injury that results in substantial harm to the child. Family Code 261.001(1)(D).

#### ASSAULT.

Intentionally, knowingly, or recklessly threatens another with imminent bodily injury or causes bodily injury to another.

Texas Penal Code 22.01

#### DEADLY CONDUCT.

Recklessly engaging in conduct that places another in imminent danger of serious bodily harm. Texas Penal Code 22.05

#### PERJURY.

Making false statements under oath. Texas Penal Code 37.02

#### TAMPERING WITH WITNESSES.

Agreeing with or coercing a witness to testify falsely in an official proceeding. Texas Penal Code 36.05

#### TAMPERING WITH GOVERNMENT RECORD.

Knowingly making a false entry in, or false alteration of a government record or makes, presents, or uses a government record with knowledge of its falsity. Texas Penal Code 37.10

#### ABUSE OF OFFICIAL CAPACITY.

A public servant comits the offense if with intent to obtain a benefit or intent to harm another or to defraud another, he intentionally or knowingly violates a law relating to the public servant's office or employment. Texas Penal Code 39.02

#### OFFICIAL OPPRESSION.

A public servant comits the offense if under color of law intentionally denies or impedes another in the excercise or enjoyment of any right, previlege, or power, or immunity knowing his conduct to be unlawful. Texas Penal Code 39.03

#### FAILURE TO REPORT A FELONY.

Failure to report the commission of a felony to law enforcement in which serious bodily harm or death may have occurred. Texas Penal Code 38.171

CRIMINAL CONSPIRACY (a) A person comits a criminal conspiracy if, with

- (a) A person comits a criminal conspiracy if, with intent that a felony be committed:
  - (1) he agrees with one or more persons that they or one or more of them engage in the conduct that would constitute the offense; and
  - (2) he or one or more of them perform an overt act in pursuance of the agreement.
- (b) An agreement constituiting a conspiracy may be inferred from acts of the parties. Texas Penal Code 15.05

#### IMPROPER INFLUENCE.

- (a) A person comits an offense if he privately addresses a representation, entreaty, argument, or other communication to any public servant who excercises or will excercise official discretion in an adjudicatory proceeding with an intent to influence the outcome of the proceeding on the basis of consideration other than those authorized by law. Texas Penal Code 36.04

#### OBSTRUCTION AND RETALIATION.

- (a) A person comits an offense if he intentionally or knowingly harms or threatens to harm another by an unlawful act:
  - (1) in retaliation for or on account of the services or status of another as a:
    - (A).witness, prospective witness...
    - (B) Person who has reported or who the actor knows intends to report the occurrence of a crime; or
  - (2) To prevent or delay the service of anothers as a:
    - (A)....witness, prospective witness....

RELIEF.


For all these reasons, I respectfully request your office:
